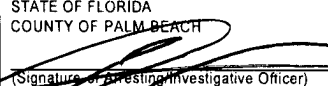
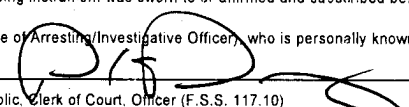

On Monday, June, 26th 2017, at approximately 0445 hours, I responded to 4444 Flows Way, Lake Worth, Fl 33461, in reference to a domestic dispute. Upon my arrival, I spoke with defendant who identified herself to me as Angelita Wofford. She stated that she and her Aunt, Victim Crystal Reynolds got into an argument inside the residence that they live in together. Wofford explained that Reynolds son stole a wine cork opener from her so she went into his room to look for it. That is when she was confronted by Reynolds and a verbal argument ensued. She stated that she reached her breaking point and "Thats why she is bleeding". At this time, I spoke to Reynolds who called 911. She stated that she caught Wofford in her son's room and told her to get out. She stated that Wofford became angry and began scratching her. I observed several minor lacerations to her wrist consistent with being scratched. She stated that Wofford also picked up a lawn ornament and threw it at her. Reynold's refused to provide a sworn statement or let me photograph her injuries. Reynold's stated that she does not want to cooperate in this case. It should be known, Wofford did not have any injuries. I asked Wofford if she caused the scratches to Reynolds and she stated "Yeah, She pushed me to do it". Based on the above described investigation, I find probable cause exist to arrest Wofford for Simple Battery (Domestic Related), pursuant to Florida Statute 784.03(1) (a)(1). Wofford was placed into handcuffs, which were double locked and checked for proper fit. Wofford was transported to the Palm Beach County Jail without incident.
