Other Observations:

I saw no resting nystagmus, equal pupil size, and equal tracking. Although I repeated the instructions and the task multiple times, the defendant never followed my instructions and I was unable to check for the standardized clues. The defendant also failed to maintain the instructional stance, swayed throughout the task, stumbled, failed to follow and anticipated the stimulus, and moved her head, in spite of repeated reminders not to.

WALK & TURN:

The defendant failed to maintain the instructional stance, and started before being told, after my instructions to, "stay like that until I tell you." After stating that she understood the instructions, the defendant stated that she could not do the tasks because of "major surgery". She kept stepping off the line, raising her arms, and swaying back and forth while telling me that she could not do this task.

ONE LEG STAND:

The defendant failed to maintain the instructional stance and started before being told, after my instructions to, "stay like that until I tell you." After stating that she understood the instructions, the defendant again stated that she could not do this task because of her surgery.

FINGER TO NOSE:

The defendant failed to maintain the instructional stance and started before being told, after my instructions to, "stay like that until I tell you." After stating that she understood the instructions, the defendant failed to keep her eyes closed and head back, she moved her head and swayed throughout the task, failed to return her hands to her sides multiple times, in spite of my instructions and repeated reminders to do so, hesitated, searched, and missed tip of finger and or tip of nose multiple times.

ROMBERG ALPHABET:

The defendant stated that she could count to 30, in English. The defendant then failed to maintain the instructional stance, started before being told, and "copied me", after my instructions to, "stay like that until I tell you." After stating that she understood the instructions, the defendant failed to keep her eyes closed and head back, swayed throughout the task, and misstated the numbers as follows, "14,16,15,17."

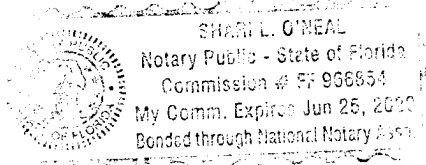

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was called to the scene of a traffic stop at the entrance of Villagewalk at 2500 Villagewalk Cir, in the Village of Wellington, in Palm Beach County, Florida. I arrived at the scene at approximately 1953 hrs. D/S Palmer #25514 told me that he had been dispatched to a suspicious person complaint. Villagewalk security guards told him that a drunk women was trying to enter the community and stated that she did not live there.

Palmer located the women at the entrance gate. When he made contact with her, he noticed articulable indicators of impairment. He had her pull to the side and called me to conduct a possible DUI investigation.

Upon my arrival, I saw the defendant sitting in the driver's seat of her blue Ford Edge bearing FL tag EQQZ60. The keys were in the ignition, the engine was running, and she was the sole occupant of the vehicle.

OBSERVATION OF DRIVER:

I made contact with the defendant, later identified by FL DL as, Angenita Grande. I observed that the defendant had red, watery, bloodshot eyes, slurred speech, and the odor of an unknown alcoholic beverage that came from her breath and intensified as she spoke to me. I asked if she had any medical problems, or took any medications. She said no. I asked how much she had had to drink. She said, "two wines."

I asked the defendant to exit the vehicle. The defendant swayed while standing, stumbled while walking, and leaned on the car for balance.

I asked the defendant to perform voluntary roadside tasks. The defendant consented and I conducted the SFSTs with the following results;

DRIVER'S STATEMENTS:

Pre Miranda / spontaneous roadside admissions: "2 wines"

Post Miranda roadside admissions: NA

Post Miranda admissions at BAT: REFUSED after Implied Consent, which she said she understood. Made post Miranda admissions that she was driving, after "2 wines".

ODORS:

Obvious odor of an unknown alcoholic beverage that intensified as the defendant spoke to me.

GENERAL OBSERVATIONS

SPEECH: slurred, slow, mumbling, incoherent, illogical, incessant, pleading, cursing, thick accent

ATTITUDE: polite, friendly, cooperative, flirtatious, annoyed, pleading, argumentative, fought, resisted, threatening

MEDICAL/OTHER: Defendant states no medical problems or medications. Based on my training and experience, and the totality of the circumstances, I determined that probable cause existed for the defendant's arrest for DUI, in violation of FSS 316.193(1).

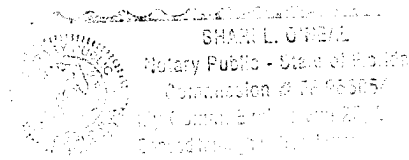
