On 03/18/18 at approximately 2337 hours, I responded to 1366 NW 14th Ct in reference to a domestic disturbance that originally occurred in the area of 51 SE 1ST Ave (Obrien's). I made contact with W/F Anisa Chick. Chick explained that she was in the area of Obrien's and Black Rose (234 S Federal Hwy) with her boyfriend of several months, W/M John Redhead and several other friends. She stated that she lost track of Redhead and she sat down on a crib and began crying. Redhead found her on the crib and she was mad at him, so she walked away and sat down on a bench. While she was on the bench, a W/M and several of his friends who approached her began flirting with her. Redhead came over and told the men to leave her alone and a physical altercation occurred which resulted in Chick and Redhead being punched. She was unsure who actually hit them during the fight. She explained that she did not know the people and she did not want a report for that incident. Chick further explained that Redhead walked away because he was upset over the altercation. Redhead sat down on a bench and had his friend, W/M Kyle King with him. Chick's friend W/M Chase Rumbley told her Redhead's location. Chick walked over to Redhead and pushed him with closed fists stating "Dude, what the heck? Did you start that argument?" Redhead then pushed her by the face causing her to fall down to the ground. It should be noted that Chick appeared to be intoxicated exhibiting slurred speech and emanating the odor of an alcoholic beverage from her breath. After that physical altercation, Redhead and Chick separated for the evening. Chick's mother called in to the police department for the altercation to be documented. I made contact with Rumbley who stated that he was close by when the argument between Redhead and Chick became physical. He explained that he was not paying attention to the couple the whole time but when he looked toward them, he witnessed Redhead appearing to shove Chick by her head causing her to fall backwards into a bush. did not see anything that may have occurred before that moment. He was told by bystanders that Chick put hands on Redhead first.

I made contact with Redhead at his residence (949 NW 8th St). He explained that Chick was highly intoxicated and got mad at him for getting lost. A W/M began flirting with Chick while she was sitting on a bench, so Redhead stated he stepped in and asked the W/M to walk away. He stated that at one point, a W/F stepped in between all of them and the W/F punched both Chick and Redhead. The groups separated immediately, Redhead walked over to a bench to wait for an Uber with King, and Chick followed. Chick was upset and punched Redhead in the face causing a visible laceration to his nose. Redhead explained that he put her at an arms distance and she fell into the bushes because she was so intoxicated. They went their separate ways after that.

Photos of Redhead and Chick's injuries were captured and submitted into the Boca Raton Evidence Department.

I made contact with King who stated that Chick walked up to Redhead who was sitting on the bench and punched him in the face. He explained that Redhead at the point stood up put his hand on her shoulder to keep her away and told her he was leaving. King stated he observed Chick fall over several times including falling backwards into a bush because she was so intoxicated.

Due to all the circumstances listed above, I had probable cause to believe that Chick was the primary aggressor due to the fact that Redhead put his arms out to create distance and avoid further physical confrontation. Chick was arrested for simple battery (domestic) per F.S.S. 784.03(1A1). She was transported to the Boca Raton Police Department for processing and later taken to the Palm Beach County Jail.
