were in town for a fishing trip. Troy stated that this evening he observed Anita get a phone call from a male named "Drew". Troy asked Anita who "Drew" was, and she immediately became defensive with the question and started arguing with him about girls that Troy could also be talking to. Troy explained that his phone was on the night stand and Anita grabbed it, as to go through it to look through his messages for potentially other girls Troy is talking to. Troy stated that Anita was holding his phone and he grabbed onto the other half of the phone and two were pulling back and forth with the phone in each of their hands. Anita then proceeded to grab and dig her nails into Troy's neck causing a laceration. Troy them released his grip on the phone. He then went to try and retrieve it again, when Anita drove her knee or foot into his right thigh causing him a great deal of pain. After getting his phone back when Anita put it down Troy, stated that Anita wanted her belongings from the vehicle. Troy grabbed the keys and walked to the door where Anita was standing with the door open. Troy explained that Anita wanted the keys, but Troy didn't want her to have them. He then proceeded to unlock to car and ushered Anita out of the door with his arm on her back. He then closed the door and dialed 911. I observed Troy's person and he had a visible laceration to his neck consistent with being scratched. Ofc. Clinard took a photo of Troy's injury with his MVR and submitted it into evidence.

I then spoke with Anita, who was downstairs in the parking lot. According to Anita, they both did get in argument regarding the male who called her on the phone. Anita stated that she wanted to leave so she grabbed the keys and was exiting when Troy confronted her and forcibly removed them from her hand. Anita stated that she then grabbed her phone and Troy tried to take that from her as well. He also pushed her in the kitchen area to get the phone. Anita stated that she did scratch and potentially bit Troy to prevent him from taking her phone. Anita then asked Troy for the keys and he stated no. Anita explained that Troy then pushed her out of the hotel room without giving her the keys. I observed Anita and she did not have any visible injuries and she was not complaining of any pain.

Based on my investigation, statements from both parties, and Troy's injuries I arrested Anita Hahn for domestic simple battery in pursuant to F.S.S. 784.01(1A1). Troy was provided with a domestic right pamphlet by Ofc. Clinard and the receipt was turned into BRPD records. Anits was transported to the BRPD booking facility for processing and ultimately to Palm Beach County Jail.
