Elizabeth Jackson called Jupiter Police Dispatch and stated a white female (later identified as Ann Marie Reiman) was driving a white Mustang around the neighborhood and had parked outside her residence, drinking a bottle of wine. Elizabeth Jackson and Gary Jackson (her husband) later completed written witness statements. Gary Jackson took video of Reiman from his balcony of her playing music and drinking from a bottle in her car. Upon the arrival of Officer Baynham, the keys were in the ignition and music was playing from the vehicle. I later found the hood of the vehicle to be warm to the touch.

OBSERVATION OF DRIVER:

Upon my arrival, Reiman was sitting in her vehicle. There was a large, half empty (or half full) bottle of wine in the center console compartment. Reiman had bloodshot, glassy eyes.

DRIVER'S STATEMENTS:

Reiman stated she had just come from a Wine Tasting at Cooper's Hawk Restaurant.

ODORS:

Odor of unknown alcoholic beverage on breath.

GENERAL OBSERVATIONS

SPEECH: Slurred

ATTITUDE: Cooperative, mood swings, joking inappropriately, sarcastic, angry, crying, impatient

CLOTHING: Black shirt, white pants, walking boot on foot

MEDICAL/OTHER: Broken foot

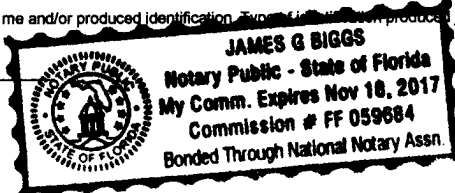

Other Observations:

Conducted Seated HGN. I had to constantly remind Reiman not to move her head. All roadside tasks were the seated battery of roadside tasks as Reiman had a broken foot and walking boot on.

Finger to Nose

Reiman started early. L1: Reiman hesitated, searched, used the pad of her finger, missed the tip of her nose, and did not bring her hand down to the side when directed. I had to remind Reiman to tilt her head back again. R2: Reiman turned her head towards her finger, touched her face near the corner of her eye, and searched for the tip. L3: Reiman opened her eyes, moved her head towards her hand, missed the tip of her nose, and did not bring her hand down after touching. R4: Reiman opened her eyes during the task again. They remained open for the remainder in spite of my repeated directions to close her eyes. R5: Reiman used the wrong hand at first and then corrected herself. Reiman used the pad of her finger. L6: Reiman used the wrong hand at first before correcting herself. Reiman missed the tip of her nose, touching to the left of the tip.

During the task, Reiman was losing patience with me and expressed that she was annoyed several times.

Palm Pat

Reiman started to count as instructed, but when I reminded her to speed up, Reiman stopped counting altogether. Reiman rolled her hands multiple times, and near the end began to double pat on each count (last 5-6 times).

Hand Coordination

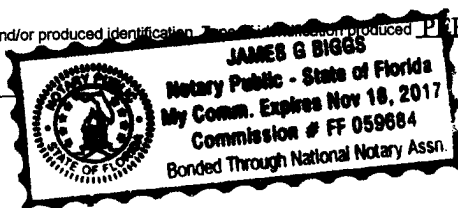
Reiman started the task and did not do Task 1 at all. Reiman then clapped four times. Reiman did not complete Task 3 at all. Reiman then put her hands out in front of her before placing them on her lap.
