Domestic Violence - Dating Violence - Probable Cause Affidavit Narrative:

On February 9, 2019 at approximately 11:07 pm. I responded to 138 Magnolia Way, Tequesta, Florida. In reference to a 911 report of domestic battery.

Upon my arrival I met with Taylor Sessa (Victim). Sessa explained he was at Anna Pinto Ovalle (suspect/ girlfriend) family's function. He left the party and went home without his girlfriend. Pinot Ovalle went to his home and began banging on the door to let her in. He stated that she continued to bang on the front door and surrounding windows for several minutes until he let her into his home. Sessa stated that Pinot Ovalle attacked him with several punches and scratched him several times. He stated that he fought her off and she began to damage the inside of his house. Once he told her that he was calling 911 she ran into the bathroom and locked the door.

Upon entering the house, I noticed damaged glass on the floor and a broken picture frame in the living room area. I then moved to the back of the home where the suspect was located. After speaking with her, she agreed to exit the bathroom. She was then escorted outside of the residence. Once outside she explained that they were fighting, but declined to elaborate.

She was then placed into custody and transported to the Tequesta Police Department for further questioning. However, once she was advised of her Maranda rights, she declined to speak without a lawyer. Photographs of her injuries were taken and documented. A search of the suspect was conducted by female officer from Jupiter Police.

Anna Pinot Ovalle was charged in violation of Florida State Statue 784.03.1a1, domestic battery. It should be noted that the suspect and victim do not reside together, but are in a relationship.

The suspect was taken to the Palm Beach County jail without incident.
