check cashing fraud complaint. I received information that a white female wearing a pink tank top and black shorts by the name of Annie lles had entered the store and handed over to the clerk, a check from Anthony Pollak to her in the amount of 300.00 dollars. The clerk advised that she felt suspicious of the phone number Ms. Iles provided for her to verify the check, so she contacted the Corporate office to have the check verified. This is when the clerk, Ms. Myrlande Luctama was notified that the check owner, Mr. Pollak reported his check book stolen and all checks therein. Ms. Luctama contacted the PBSO to report the fraudulent transaction. Upon my arrival in the store, I met with Ms. Iles who was standing in front of the front counter window. She advised me that she had entered the store to cash a check and was waiting on the clerk to continue assisting her. Mr. Cooke had entered the store and advised that he was waiting on Ms. Iles to complete the check cashing transaction. I informed both subjects at the time why I was there. I identified both subjects by their FL driver's license and separated them as I obtained basic indentifying information. I then contacted the victim, Mr. Pollak who informed me that he did not give anyone permission to cash a check or use his check. He explained that he did not know who had taken the check book and that he has not used the account in several years. I brought Ms. Iles out to my patrol vehicle to conduct a video recorded sworn interview. I read Ms. Iles her constitutional rights in which she verbalized that she understood. Ms. Iles advised that she observed Mr. Cooke use a blue writing pen to fill out the check in her name and forge Mr. Pollak's name. She stated that she does not know Mr. Cooke very well but knows that his name is Jeff and he works odd jobs with her boyfriend named Cliff. She stated that she got into the UHaul van with Mr. Cooke and they drove to the check cashing store so that she could go inside to cash the check.

I then interviewed Mr. Cooke on my in-car video camera and read him his constitutional rights, in which he verbalized that he understood. Mr. Cooke informed me that he got the blank check out of his mother's purse and he knew that the check did not belong to his mother. He stated that he and Ms. Iles agreed to go cash the check because he needed money. He also stated that he was not the one who filled out the check but he knew that the check was fraud.

Both subjects were arrested and placed into handcuffs that were properly checked for tightness and double locked.
