NARRATIVE:

On Saturday, August 19th, 2017 at approximately 2132 hrs I responded to a domestic disturbance at the North Church Parking lot of Perfect Vodka Amphitheater, located 601 Sansbury Way, in unincorporated West Palm Beach, Palm Beach County, Florida, 33411.

While en route I was advised over the radio that D/S C. Palenzuela I.D. 5849 of the Palm Beach County Sheriff's Office Civil Divison advised over the radio that she was out with a domestic altercation. D/S Palenzuela advised that she had the parties seperated at this time.

Upon arrival it was learned that D/S Palenzuela and C.S.A. L. Hines I.D. 9809 of the Palm Beach County Sheriff's Office District 6 Road PAtrol Divison had observed a verbal altercation taking place between a male and female subject.

C.S.A. Hines advised that he observed the male subject grab the female subject by her right arm as they walked through the parking lot pulling her along. D/S Palenzuela advised that she did not observe the physical altercation however she did observed the verbal altercation and detain the male subject who was later identified as Anthony Cellucci.

Upon speaking with Anthony he denied any wrong doing. Anthony stated that the female subject was his wife of 13 year identified as Taryn Cellucci. Anthony stated that he and Taryn were walking back to their friends car talking.

NARRATIVE CONTINUATION

Sgt. J. Eley I.D. 9134 of the Palm Beach County Sheriff's Office District 14 Road Patrol Division arrived on scene as back up. Sgt. Eley met and spoke with Taryn at which time she stated that she was leaving the concert with her husband and friends. Taryn advised that she began holding her male friend's hand at which time she stated that Anthony became angry believing that she was attempting to have a relationship with the other male who was later identified as Grady Hutchins.

Taryn advised Sgt. Eley that Anthony became angry and grabbed her by her right arm pulling her slightly behind him. Taryn advised Sgt. Eley that once they entered the north church parking area Anthony shoved her causing her to fall to the ground. Taryn confirmed that she and Anthony are husband and wife of 13 years with two children in common and that they currently reside together in Jupiter, Florida, 33485. D/S N.Jackson I.D. 7175 later took Digital photographs of Taryn for evidentiary purposes.

D/S C. Palenzuela later obtained a sworn written statement from Hutchins who stated that he was in fact walking with Taryn and Anthony headed to the north parking lot. Hutchins advised that he was holding Taryn's hand so she would not get seperated from the group. Hutchins stated that Anthony became angry and grabbed Taryn by her right arm. Hutchins stated that he did not see Taryn get pushed to the ground.

At this time based on the above information there was probable cause for the arrest of Anthony Hutchins for Simple Battery (Domestic Violence) contrary to F.S.S.
