Narrative						
On Sunday Sept. 18, 2016 at 1614 hours Ofc. McAllister and I responded to the area of 6711 N. Ocean Blvd. in reference to a male 9-1-1 caller named Tony who would not give a last name or apartment number. Because of previous domestic violence calls at apartment 17 I checked this location first. I met with the Anthony C. Tuttle W/M 08/16/1965 who stated that he was in fact the 9-1-1 caller because [REDACTED] had pushed him down the steps. Tuttle had no visible injuries and advised that he had none. I could detect the odor of an alcoholic beverage on or about his person. I then met with [REDACTED]. I observed a raised, bruise under the left eye and swelling on both sides of her face. [REDACTED] stated that they both had been drinking champagne. During this time a verbal argument occurred which then became physical when Tuttle began slapping her in the face. [REDACTED] became fearful for her life and ran up stairs to the second floor and locked herself in the bedroom. In the course of defending herself as she was running upstairs, [REDACTED] pushed Tuttle. Tuttle slipped on the stairs but caught himself prior to falling. [REDACTED] then locked herself in the bedroom. Tuttle was unable to get into the bedroom because the door had been locked. Tuttle forced two doors and made entry into the bedroom. Tuttle then began to slap [REDACTED]. During my interview with [REDACTED] I could detect the odor of an alcoholic beverage on or about her person as well. [REDACTED] refused any medical attention. [REDACTED] completed a Victim/Witness Affidavit outlining the incident as she recalled it. [REDACTED] was issued and signed a Domestic Violence information packet. Digital photographs of [REDACTED] and her injuries as well as the door and bedroom area. The digital photo memory card was placed into evidence. Based on the facts and evidence that I observed I was able to determine that Tuttle was the primary aggressor in this case and did commit the crime of domestic battery. It should be noted that [REDACTED] and Tuttle are not married but do reside together as a family. Based on the risk assessment form completed I called a victim advocate at 561-833-7273 on the behalf of [REDACTED]. Tuttle was taken into custody and transported to the Ocean Ridge Police Department for processing. He was then transported to the Palm Beach County Jail.
