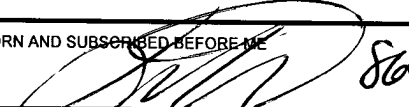
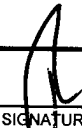

On the 31 day of December, 2017 at 19:44 (Specifically include facts constituting cause for arrest.) On 12/31/2017, at approximately 1925 hours, I Officer Cummings ID# 848, responded to 301 E Ocean Ave Lantana, FL 33462 in reference to a W/M being disorderly and pulling on car door handles. Upon my arrival I made contact with W/M Anthony Haugan 06/26/1955. While walking up to Anthony I observed him swaying back and forth pulling on a car door handle. The vehicle did not belong to Anthony and he did not have a reason as to why he was pulling on it. Anthony was very intoxicated and was being belligerent with officers when he was asked for his identification. I then made contact with the bar manager of the Old keylime house and caller W/M Michael Gamboa D.O.B 10/31/1980. Michael stated that Anthony was inside of the old Keylime House causing a disturbance, yelling and screaming at bar patrons. Michael stated that he advised Anthony to leave the bar which he did. While Anthony was leaving the bar he was in the parking lot yelling and screaming profanities at Michael and more bar patrons. Michael advised me that he was offended by the language Anthony was using in public and by how he was being treated and spoken to. Michael also stated that Anthony was scaring away his bar patrons. I once again attempted to get Anthonys ID from him but he refused to give it to me stating that he did not have to. At this point in time I advised Anthony that he was being placed under arrest for disorderly intoxication and resisting without violence. He was handcuffed (Double locked checked for tightness and fit). Anthony was processed and later transported and lodged at the Palm Beach County Jail. Michael filled out and completed a sworn written statement of the noted events.
