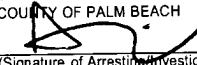

I was dispatched to 724 Venice CIR #204 in the Town of Lake Park, FL in reference to a domestic disturbance. A verbal argument ensued over the defendant being jealous of the victim talking to other guys on Facebook which later turned physical. The victim alleged the defendant unlawfully assaulted her by grabbing her head and slamming it into the center console inside a vehicle and then grabbed her by the hair and threw her to the concrete parking lot floor. The defendant kicked and punched the victim several times and took her cellphone away when she threaten to call 911. I observed visible injuries all over the victim's face, arms, and legs but was unable to locate any cooperative witnesses. The victim was transported to Palm Beach Gardens Medical Center for further medical treatment. Photographs were taken on scene and the victim provided a sworn written statement. The victim and defendant live together as a couple and have 1 child in common. I determined the defendant was the primary aggressor and believe probable cause exists to charge them with Simple Battery Domestic and Tampering with a Victim.
