(D-Favarulo) while being intoxicated, cause a disturbance in a public place and endanger the safety of another person (W-1 Grieco). After (D-1 Favarulo) was notified he was under arrest did knowingly resist this officer while in the lawful execution of my legal duties by refusing to be handcuffed and pulling away from this officer's grasp. (D-1 Favarulo) and (W-1 Grieco) were involved in a verbal argument where (D-1 Favarulo) attempted to drive away in a 2002 Ford Truck FL # Y80PBD. (W-1 Grieco) removed the keys from the vehicle due to (D-1 Favarulo) being intoxicated. (W-1 Grieco) also advised that (D-1 Favarulo) had been arguing with Favarulo's girlfriend (W-2 Carlin) about driving intoxicated. While talking with (D-1 Favarulo) he became very agitated about getting his keys back from (W-1 Grieco) and began cussing and spitting at him. This officer smelled a very strong odor of an alcoholic beverage on his breath, slurred speech and blood shot eyes. (D-1 Favarulo) Then started to yell at (W-1 Grieco) that he was going to kick his ass and wait until us (Police) left he would take care of business. At this point this officer placed the (D-1 Favarulo) under arrest. Myself and Sgt Stang placed (D-1 Favarulo) under arrest and due to (D-1 Favarulo) resisting I was unable to double lock the handcuffs, and check for tightness.
