On August 13, 2016 at approximately 6:08 P.M., while I was employed with The Palm Beach County Sheriff's Office (PBSO) North Region District 3 Road Patrol Division, working in a marked PBSO patrol vehicle equipped with emergency lights, sirens, PBSO insignia, and wearing a PBSO road patrol uniform, I was assigned to patrol unincorporated West Palm Beach.

While I was on patrol, the PBSO Dispatch received a call from a Janaina Pulieri, who resides at 2518 Monaco Terrace, Palm Beach Gardens, FL 33410. Janaina told the dispatcher that her husband was hitting her, chasing her around the house and was going to kill her. I was then dispatched to investigate.

Upon my arrival I made contact with a white female who identified her self as Janaina Arujo Puliero, date of birth 08/05/1976. Janaina told me that her husband by the name of Tony was screaming at her in the kitchen as she was cooking dinner. Janaina told me that Tony pushed her on her shoulders with his hands and caused a cooking utensil to fall out of her hand. Janaina went into the bathroom to separate herself from Tony and she told Tony that she was calling the police. Janaina stated that Tony forced his way into the bathroom and tried to pull the phone out of her hand. Janaina was able to keep the phone in her hand, but the phone casing was damaged due to the struggle. Janaina stated that she locked the bathroom door so that Tony could not gain entry again. Janaina stated that Tony again tried to force the door open, breaking the molding of the door. Janaina told me that she screamed to Tony that she was speaking to the police and Tony left the house by automobile. Janaina stated that her two children by the names of Sofia and Marco witnessed the event. Janaina had no marks, cuts, bruising or swelling on any areas of her exposed body. Janaina did not appear to be under the influence of drugs or alcohol. Janaina completed a video taped sworn witness statement.

I spoke to Sofia Puliero, date of birth 01/05/2010. Sofia stated that she saw Dad push Mom in the kitchen. I spoke to Marco Puliero, date of birth 08/22/2011. Marco stated he saw Dad push Mom in the kitchen.

Outside the residence I made contact with a white male who identified himself as Anthony Joseph Pulieri, date of birth 10/05/1979. Anthony stated in a post-Miranda audio taped witness statement that he was arguing with Janaina in the kitchen today after she came home from the beach. Anthony admitted to trying to take the cell phone away from Janaina while she was trying to call the police. Anthony denied ever pushing Janaina in any way whatsoever. Anthony had no marks, cuts, bruising or swelling on any areas of his exposed body. Anthony did not appear to be under influence of drugs or alcohol.

Based on the above facts, statements, my training, experience and observations, I find that there is probable cause that Anthony Joseph Pulieri willfully and unlawfully battered Janaina Pulieri against her will, contrary to Florida Statute 784.03 1a1. I find that there is probable cause that Anthony Joseph Pulieri willfully and unlawfully prevented Janaina Pulieri from contacting law enforcement, contrary to Florida Statute 914.22(1)(e).
