PERSONAL CONTACT

NARRATIVE:

On 09/09/2016 at approximately 2256hrs I was dispatched and responded to 433 Palo Alto Drive Palm Springs, FL 33461 in reference to a domestic disturbance. Upon arriving I made contact with Miguel Ribera, victim. Ribera was shirtless and stated he and his wife, Arellys Vanessa Betancourt was involved in a physical altercation over divorce issues. Ribera stated he was taking a shower in the master bedroom's bathroom; when Betancourt walked in to urinate. Ribera stated they started verbally arguing and Betancourt became upset and scratched him on the left side of his back as he attempted to get into the shower. Ribera had bright, red marks consistent with scratches on the left side of his back. Photos of said injuries were taken and submitted into evidence. Ribera did not want medical attention.

I spoke with Betancourt she stated Ribera was taking a shower and she went in to urinate when Ribera grabbed her by the hair and was attempting to force her into the shower. Betancourt never stated there had been a verbal argument prior to the physical altercation. Betancourt did not have any visible injuries to her person.

Both parties stated their minor children did not witness the altercation and were sleeping at the time.

Betancourt was arrested for domestic battery. F.S.S. 741.28. Betancourt was transported to Palm Springs Police Department's holding cell in order to complete the proper paper work. Betancourt was then TOT to county jail.

DEFENDANT'S STATEMENTS: (Written / Taped / Oral)

Betancourt stated Ribera was taking a shower and she went in to urinate when Ribera grabbed her by the hair and was attempting to force her into the shower. Betancourt never stated there had been a verbal argument prior to the physical altercation. Betancourt did not have any visible injuries to her person.

VICTIM'S STATEMENTS: (Written / Taped / Oral)
