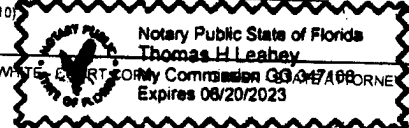

On Thursday, November 14, 2019 at approximately 21:53 hours I was conducting traffic enforcement in the vicinity of Sandalfoot Plaza Drive and Sandalfoot Boulevard in the unincorporated Boca Raton, Palm Beach County Florida. I observed as a dark four door vehicle was backing away from a parking spot right in front of O'Connor's Pub (9900 Sandalfoot Boulevard). I observed the vehicle had no tag light. I then conducted a traffic stop by activating my overhead lights of my marked patrol unit on the same vehicle bearing Florida tag DVFN67. Before the vehicle came to a stop, the driver, drove around the parking lot before coming to a complete stop on the same parking spot it was when I observed the vehicle leaving. The driver immediately exit the vehicle and began to walk towards me. I order the driver to get back into the driver seat and he complied. I then approached the vehicle on the driver side window and the driver opened the driver door. I made contact with a white male identified by his Florida driver license as Arend R. Ferwerda. Arend is the registered owner of the Cadillac CTS four door vehicle. I explained Arend the reason of my traffic stop to what he replied "ok." I could smell immediately a strong odor of an alcoholic beverage coming from his mouth/facial area as well as a mild slurred speech, glassy, watery, and bloodshot eyes. As I was informing Arend of my observations he spontaneously uttered "I just came from O'Connor's from getting a six pack." I asked Arend if he had anything to drink to what he replied "no." I observed a carton with six cans of beer unopened along with three open cans of beer on the passenger floor board. It should be noted that as Arend continue to talk, the strong odor of alcohol coming from his facial area became stronger. Arend stated "I work a lot, that is all I can tell you about that." in reference to my statements about his odor and eyes. Arend then handed me a 2015 expired vehicle registration and advised he did not have his insurance card with him. I asked Arend if he was willing to perform a series of exercises called field sobriety exercises to what he replied, "I am not going to do anything without my lawyer present." Arend continue to interrupt me saying he did nothing wrong and that he worked 14 hours at his shop. I tried to explained Arend his Taylor warnings but he repeatedly interrupted me talking over my words. I gave Arend several opportunities to perform the exercises to what he refused all of them. Arend was placed under arrest at 2205 hours, handcuffs were double locked and checked for proper fit before placing him in the rear seat of my marked patrol unit. Arend was transported to the Palm Beach County Jail for booking without incidents. We arrived at the BAT Facility at approximately 23:21 hours and ensured that Arend did not have any foreign objects in his mouth. I then began my 20-minute observation period, during which he did not regurgitate or take anything by mouth. Once completed he was brought into the videotaped breath test room. I asked if he would provide a sample of his breath for the purpose of determining its alcohol content to what he replied "I will not do anything without my lawyer." I then began to read him Implied Consent. After Implied consent was read Arend still refused. It should be noted that Arend has a prior refusal to submit to a lawful test. I then read him his Miranda Rights/Constitutional Warnings. After reading him his rights and explaining them until he understood, he indicated that he would not speak to me. I then used the "Question & Answers" sheet supplied by the BAT to ask him a series of questions regarding his operating of a motor vehicle, his alcohol consumption, along with other questions. Arend only responded to the first question and said he would not continue (see questionnaire in DUI packet). Once completed, he was brought into a holding cell while I completed my paperwork. Once completed, Arend was brought to the intake area of the Palm Beach County Jail where he was booked and processed for the charge of DUI. The citations and charges were explained to Arend prior to my departure. Based on the facts, circumstances, and totality of my investigation I do find probable cause to charge Arend R. Ferwerda with driving under the influence (DUI) Florida State Statute 316.193(1), and DUI refusal to submit to testing based on his prior refusal Florida State Statute 316.1939. This case is clear by arrest.
