On Monday November 25, 2019 at approximately 0412 hours, I observed a silver van bearing the Florida tag of GMQW33 traveling north on S. Dixie Hwy from 6th Ave S. The vehicle was unable to maintain a single lane and ran a stop sign at 4th Ave S and S J Street. As a result, I activated my emergency overhead lights and sirens and conducted a traffic stop. I approached the vehicle on the driver side and identified the driver as Arlen Rubio (FL DL#R100000918360). She seemed disoriented and had slurred speech. I ran Arlen's Florida Driver's License through FCIC/NCIC [REDACTED]. While on scene I was advised by a witness that the silver van that I was out with was involved in a vehicle crash nearby. I walked to 405 S K Street where I observed a gold color Honda Accord with the Florida tag of Y68RHJ with right front damage. It is to be noted that Arlen's vehicle had extensive right front damage. The witness advised the silver van was traveling southbound in the northbound lane of travel. I observed a large piece of Arlen's vehicle on scene of the crash. I conducted a crash investigation as well as my traffic stop. Due to the totality of the circumstances, I found probable cause to charge Arlen Rubio with leaving the scene of an accident with property damage, driving while license suspended with knowledge, and careless driving.
