I walked to 405 S K Street where I observed a gold color Honda Accord with the Florida tag of Y68RHJ with right front damage. It is to be noted that Arlen's vehicle had extensive right front damage. The witness advised the silver van was traveling southbound in the northbound lane of travel. I observed a large piece of Arlen's vehicle on scene of the crash. I conducted a crash investigation as well as my traffic stop.									
	Due to the totality of the circumstances, I found probable cause to charge Arlen Rubio with leaving the scene of an accident with property damage, driving while license suspended with knowledge, and driving.
