On Saturday June 23, 2018 at approximately 2359 hours I, Officer M. McCray II observed a black 2017 Ford Fiesta (Bearing FL Tag # JHEE13) traveling west on PGA Boulevard approaching Interstate 95 in Palm Beach Gardens, in Palm Beach County, Florida. I observed the vehicle traveling approximately 60mph in a 45mph zone. I activated my emergency lights conducting a traffic stop on the described vehicle at PGA Boulevard and Gardens Lakes Boulevard. My body-worn camera was activated.

I made contact with the driver, Dale Snow, who was identified by his Kentucky driver's license. At the time of this traffic stop, the front passenger seat was occupied by Ashley George, and the driver's side rear seat was occupied by Ashley Harris. I explained to Snow the reason for the stop and asked for his license, registration, and proof of insurance. Snow then produced the documents. While speaking with Snow, I could detect a strong odor which through my training and experience knew to be marijuana coming from within the vehicle, and in plain view was a plastic Ziploc style baggie inside of Georges unzipped backpack. I then asked Snow to exit the vehicle and asked if there was anything in the vehicle which I should be concerned with, and Snow advised not to my knowledge. Snow then sat down on the curb along with the other occupants. I asked the occupants if there was any marijuana inside of the vehicle before I conducted a search. Snow and Harris denied possessing any illegal narcotics. George then stood up and stated, "lets talk." George stated she had recently purchased some marijuana and placed it inside of her backpack. I then conducted a search of the vehicle.

Upon searching the vehicle, I observed a small plastic baggie containing suspected marijuana in a blue and black backpack positioned in the passenger seat of the vehicle belonging to George. The suspected marijuana tested positive for THC using a Duquenois-Levine Reagent field test kit. The suspected marijuana weighed approximately 30 grams. George was placed into handcuffs which were checked for proper spacing and double locked and advised of her Miranda rights. The marijuana was placed into

evidence. Post Miranda George stated the marijuana belonged to her.

Based upon my investigation, I find probable cause to arrest George for (1) count of possession of marijuana more than 20 grams pursuant with Florida State Statute 893.13(6) (A). Snow was issued a written warning #W064450 for the speed violation. Snow, and Harris were subsequently released from the scene. George was transported to the Palm Beach Gardens Police Department for processing, and later to the Palm Beach County Jail for booking.
