On 01-20-17 at approx: 18:00 hrs I was notified by Sgt. Euell to respond to the intersection of St. Rd 80 and Little Ranches trail in reference to assisting a PBSO District 8 road deputy with a vehicle that was stopped for a traffic violation.

Upon arrival I made contact with D/S Jon Alvarez # 17620. Alvarez advised he stopped 2008 White Ford bearing Fl tag Y75-NNI for failure to drive within a single lane. The driver/sole occupant of the vehicle was identified as W/F Ashley Nicole Bowden (05-11-1993).

Alvarez then asked for and received consent to search the vehicle. Upon opening the trunk of the vehicle Alvarez observed 21 large glass "mason" style jars that contained marijuana residue. Due to the number and size of the jars Alvarez requested a PBSO narcotics agent respond to talk with Bowden.


I then introduced and identified myself to Bowden. I asked Bowden to have a seat in my vehicle in the front passenger side.

Once in my vehicle I activated a digital recorder and read Bowden her Miranda rights. Bowden signed and advised she understood her rights.

From my interview Bowden advised she just left her residence and knew that the jars where in the trunk of the vehicle she was driving and also knew that they contained marijuana residue. Bowden also advised that the jars came from her garage and her mother's live in boyfriend "Jim" asked that she get rid of them for him. Bowden also stated that she is the one that placed the jars into the trunk of the vehicle but she did not have a plan as to where she was going to dispose of them.

Due to the above information Bowden was placed under arrest for transportation of Drug Paraphernalia pursuant to F.S.S. 893.147 (4)
