The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law.

committed the below acts in my presence. was observed by **SGT. DALY** who told **DEC. MARTINEZ** that he/she saw the arrested person commit the below acts.

confessed to _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **18** day of **March**, **2019** at **22:54** (Specifically include facts constituting cause for arrest.)

On 03/18/19 at approximately 2222 hours, I responded to 130 Sea Island Terrace in reference to a suspicious vehicle encountered by Sgt. Daly while he was conducting a security check. Upon arrival, I made contact with Sgt. Daly who was present on the scene.

Sgt. Daly stated the following: While he was conducting a security check of the surrounding area he noticed a red Honda Accord bearing NY Tag HTB1894 parked on the side of the road. The vehicles tail lights and headlights were on. He approached the vehicle and smelled an odor of marijuana emanating from the open driver side door. An occupant was present in the vehicle and was later identified as Ashley Serrata. At the same time, he observed in the center console cup holder, a clear plastic bag containing a green substance, which through his training and experience lead him to believe was marijuana. I then searched the vehicle belonging to Serrata and discovered a glass pipe with marijuana residue on it in the front driver side door area. A cigarette box containing a green leafy substance was also present in the front driver side door area. In the center console, I observed a clear plastic baggy containing a green leafy substance. Beside the plastic baggy was a pill bottle containing a green leafy substance. I tested the green leafy substance with a Lynn Peavey Quick Check Test Kit and it tested positive.

Serrata was in possession of less than 20gm of Marijuana, which is a violation of FSS 893.13(6) (b). She was also in possession of drug paraphernalia, which is a violation of FSS 893.147 (1) (b). I placed Serrata under arrest for the above-mentioned offenses and she was transported to BRPD booking where she was processed for transport to Palm Beach County Jail. The suspected marijuana was weighed at 7.3 grams with baggy, and the paraphernalia and suspected marijuana were submitted into evidence.
