	<p>On Thursday, March 15, 2018 at 2:51am, I, Officer Cameron Carver, while conducting a traffic enforcement at PGA Boulevard and Lake Victoria Gardens, observed a vehicle (black Kia Forte bearing Florida tag 298PPF) traveling westbound on PGA Boulevard with a headlight out. I initiated a traffic stop on the Kia at PGA Boulevard and Kew Gardens. I made contact with the driver, Avery Francois and passenger, Ashly Kersey. While speaking with the occupants I detected, what I knew based off my training and experience, to be the odor Marijuana emanating from the vehicle.</p> <p>Both occupants were requested to exit the vehicle and complied. I searched Francois and Officer Melinda Hanton #305 searched Kersey and discovered a black LG cell phone, two Travelodge hotel key-cards in her pants.</p> <p>On the passenger floorboard was a blue bag and pink Victoria's Secret bag. Inside the blue bag contained a metal pipe and pink baggie containing suspect Marijuana and tobacco. Inside the Victoria Secret bag located a black and pink-hearted "Love Me" wallet; jean shorts; long brown cloth tie with a single needle wrapped in it; Travelodge matches and purple makeup bag.</p> <p>The wallet contained the following items: Go-Bank Debit Master-Card and card activation paper which housed a small yellow plastic baggie with residue. The card had Kersey's name on it and the paperwork.</p> <p>The purple makeup bag contained the following items: (4) spoons with residue (9 1/2) empty coin-manila envelopes (1) coin-manila envelope containing two (2) blue and two (2) red baggies with suspect heroin in each.</p>

The jean shorts contained a clear cellophane wrapper with a red baggie with residue.


In the backseat of the vehicle one (1) pill was located. The pill markings were 283/IG. Poison Control (Michael Hasym #106190 Case# M3575093) confirmed the pill to be Cyclobenzaprine 10mg. This is a non-scheduled prescription, commonly known as flexural (muscle relaxer).

In the trunk of the Kia a sock containing two (2) needles and one (1) bent-spoon with residue on it.

Kersey was handcuffed, double-locked and checked for proper spacing. Officer Hanton read Kersey her Miranda Warnings. Post-Miranda I asked Kersey about the Marijuana and pipe, she stated it was hers. Kersey later stated that all the items in the vehicle belonged to her.

Based on the above facts, I find probable cause to arrest Ashly M Kersey for possession of Heroin in violation of F.S.S. 893.13(6) (a); possession of Marijuana under 20 grams, in violation of F.S.S. 893.13(6) (b); unlawful possession of prescription drugs, in violation of F.S.S 499.03(1) (3) and possession of drug paraphernalia, in violation of F.S.S. 893.147(1) (b). Kersey was transported to the Palm Beach County Jail without incident.

Field Tests
 A Dequenois-Levine Reagent test kit was used on the suspect Marijuana, which tested positive. A Nitric Acid Reagent was used on a red baggie containing a wet piece of cotton, which tested positive for Heroin and Codeine.
