PROBABLE CAUSE

On 07/30/2017 at approximately 3:56pm I was in service in Palm Beach County, Florida. I was traveling northbound on Interstate 95 (State Road 9) south of Woolbright Road when I was dispatched to a three vehicle crash which was located southbound on Interstate 95 (State Road 9), north of Woolbright Road issued through the Florida Highway Patrol (FHP) Communication Center. Prior to my arrival on scene, Sergeant Tony Kingery ID#313 advised that one of the vehicles involved of the crash was attempting to move the crashed vehicle from the left paved shoulder to the right paved shoulder by traveling south on Interstate 95 (State Road 9) cutting in front of traffic almost causing other accidents. A traffic stop was then conducted by Trooper Joan Cantelar ID#1753 to await my arrival after dealing with the other crashed vehicles. After speaking with the driver that Trooper Cantelar had pulled over, the driver was identified by his Florida Photo Driver's License as ASLAN VAROQUA, upon speaking with VAROQUA he advised me that he was involved in a crash with two other vehicles (see Crash Report). I then switched hats from a crash investigation to a criminal investigation to determine if the driver was driving under the influence. I then read VAROQUA his Miranda Rights which he stated that he understood and wanted to invoke his 5th Amendment Right. After reading the Miranda Rights, He then spontaneously told me that he has taken his prescribed medication (Gabapentin) that makes him drowsy but doesn't affect his ability to drive a car.

While talking to VAROQUA I observed that he was having difficulty maintaining his balance as well as having glassy eyes. While talking with the driver I noticed that the driver had a front to back sway as well as orbital. VAROQUA was also drooling from his mouth during the period that I was talking to him. After the roadside tasks were concluded VAROQUA almost walked into the far right travel lane of Interstate 95 (State Road 9) but Trooper Cantelar was there to prevent VAROQUA from making his way into the travel lanes. While being given instructions for exercises, VAROQUA had trouble standing with feet together and arms down by his sides as instructed.

After reading the Miranda Rights, He then spontaneously told me that he has taken his prescribed medication (Gabapentin) that makes him drowsy but doesn't affect his ability to drive a car. I then asked VAROQUA if he would like to I then asked VAROQUA if he would like to based off of my observation, if he would be willing to perform roadside exercises to check for impairment and the driver agreed. When in my patrol vehicle VAROQUA stated that I was going to have a difficult time finding him guilty cause he has not had any alcohol and drugs are hard to find guilty. VAROQUA also stated that he has the best lawyer in Palm Beach County and that he was going to get him off. VAROQUA also stated that he has beat a DUI charge before down in Delray and that he would get this charge kicked out as well. Upon arriving at the jail, VAROQUA asked me where the stuff is that he bought from the store, when asking him what he was talking about he asked again if we stopped anywhere because he wanted to crush it before he got into the jail.

Subject repeatedly looked back at me when instructed to follow light (Uncooperative when asked to follow light throughout some of the tasks)

Walk and Turn-

Subject was asked if he had any injuries or pains that would prevent him performing an exercise that requires walking, to which he responded No. Subject found a line on the right shoulder to conduct roadside that he stated he felt comfortable with, during the exercise he started to complain that he could not see the line that he found. Subject could not keep balance while listening to instructions and came out of starting position. Subject started too soon before I finished giving instructions. Subject had to stop to steady himself to pause and regain balance. Subject used his arms for balance while walking down the line. Subject missed walking heel-to-toe more than two times. Subject turned improperly and took improper number. Subject stated that he took 10 steps but did understand my instructions to take 9 heel-to-toe.

One-Leg Stand-

Subject was asked if he had any injuries or pains that would prevent him performing an exercise that requires him to lift one leg, to which he responded No. Subject started before told to do so. Subject also used his arms for balance. Subject also hopped on foot on the ground. Subject swayed during exercise and put foot down two times during exercise. Subject also restarted counting from 1 after counting to 12 while putting foot down.

Finger to Nose-
Subject was asked if he had any injuries or pains that would prevent him performing an exercise that requires touching the tip of his nose with the tip of his index finger, to which he responded that his wrist and fingers were paralyzed (moved all of his fingers that he stated were paralyzed) but his index finger was for the exercise. The subject did not keep his eyes closed throughout exercise as well as did not keep his head tilted back. Subject touched the pad of his finger to the bridge of his nose, not the tip of the finger to tip of the nose as instructed. Subject became agitated during this exercise and said that he felt it was unfair. Subject then opened his eyes and tilted head back down looking at me before exercise was concluded. Subject also used the wrong hand once.

Modified Rhombert Alphabet-

Subject did not keep eyes closed throughout exercise. Subject did not keep his head tilted back during exercise. Subject also swayed throughout exercise. Subject was asked to tilt his head back, keep eyes closed, and asked to estimate 30 seconds in his head when he felt that 30 seconds had gone by to open his eyes and say "Stop". After approximately 53 seconds had gone by the subject opened eyes and stated 30 seconds had gone by.

Based upon the totality of the circumstances, VAROQUA was then placed under arrest for Driving Under the Influence with Property Damage. VAROQUA was then placed into hand restraints were secured, double locked, and checked for tightness for his safety and mine. VAROQUA was then transported to the Palm Beach County Jail Breath Testing Center.

The Driver was identified by her Florida Photo Driver's License as ASLAN VAROQUA and was ran through FCIC/NCIC and was clear of any warrants. The four door gray Honda with TAG# CTGV68 was also ran through FCIC/NCIC and was not missing or stolen.

This incident occurred in Palm Beach County, Florida.

AFFIDAVIT OF PROBABLE CAUSE (CRIMINAL TRAFFIC CHARGES) STATE OF FLORIDA

I, Tony Kingery, hereby swear or affirm that I have probable cause to believe that the above named defendant on the 30 day of July, 2017, did commit the following violation of law:

I observed a vehicle that was involved in a crash trying to move from the left shoulder to the right shoulder. The vehicle was almost struck by several passing cars. I noticed that the vehicle had only one occupant in the car, A white male identified as the defendant on this form. The vehicle came to a stop in the lane next to the HOV lane and was again almost struck. The vehicle started to travel south on SR-9 (I-95) I advised Tpr. Cantelar to go after the vehicle. We got behind the vehicle with our lights and sirens activated and after about 1/2 a mile the vehicle finally pulled over to the right shoulder. The driver attempted to leave the vehicle and was told to remain in the vehicle by Tpr. Cantelar. We walked up to the vehicle and spoke with the driver. The driver had slow reactions to our questions he had slurred and mush mouthed speech. His clothing was very disorganized and his zipper was down. Tpr. Cantelar asked the driver if he needed medical attention and the driver advised "no I am fine". The driver appeared to be under the influence of some kind of medication. I questioned the driver about his medical history and he advised that he was taking Gabapentin and took his last dose at 2:30pm. Upon further conversation he still seemed disoriented and under the influence of medication. The listed defendant was involved in a crash before I observed him leaving the scene of the crash. The driver refused medical assistance and appears to physically be ok other then the appearance of being under the influence. I contacted the Trooper that is working the Crash and informed him that this suspect may be DUI. The other crashed vehicle's in this case stopped on the right shoulder north of Boynton Beach Blvd. and the suspect left the scene traveling south and was pulled over by myself and Tpr. Cantelar.

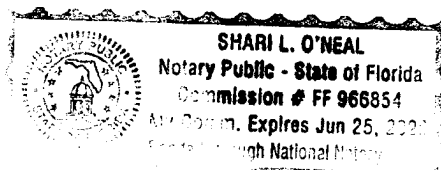

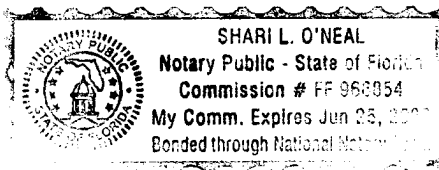

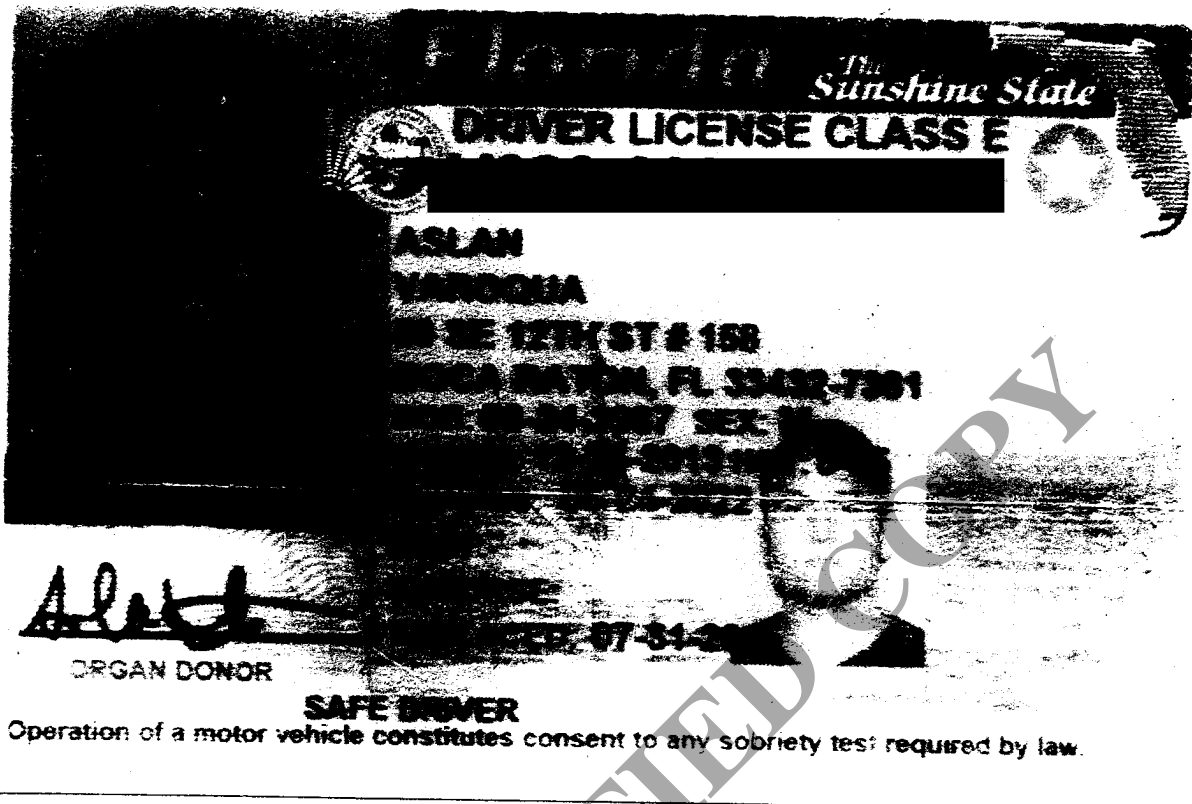
