I then advised Audrey again that D/S Aiu had concluded his crash investigation and that I will be conducting a criminal investigation.

I then made contact with the involved parties and both advised that they were not injured. I first met with the driver of the Kia, Emily Izquierdo, who advised that she was driving westbound on Lucerne Ave stopped at the light when she was hit from behind. She then advised that she exited her vehicle and observed that the gray vehicle was behind her and motioned the vehicle to move into the parking lot.

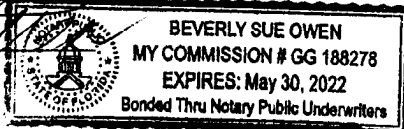

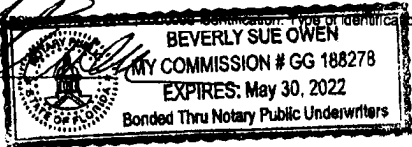

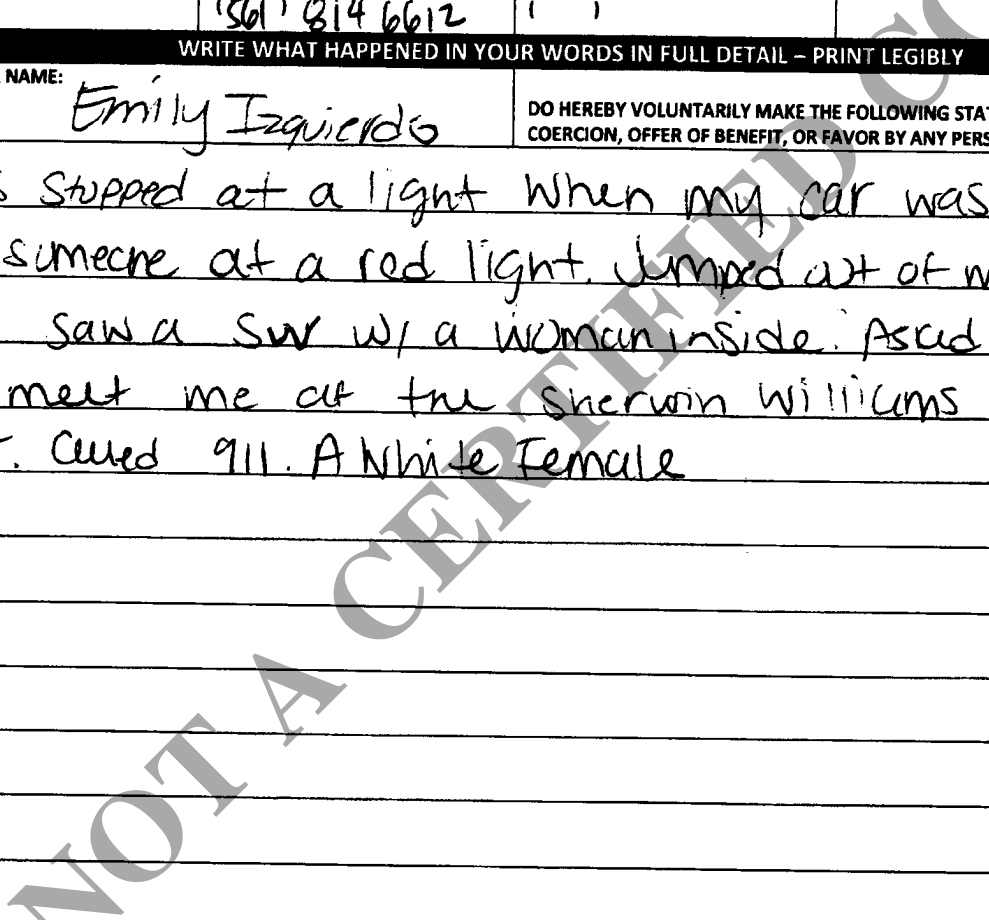
