**NARRATIVE:**

OOOn 03/03/2018 at approximately 1250Hrs, the victim, Edgar E Gaspar Gaspar (WM DOB 07/08/1995) met with 2 females in the area of the Publix supermarket in Loxahatchee FL. The 2 females were known to Gaspar as females who he had prostituted with in the past. Gaspar was driving a 2008 Red Ford Focus Bearing FL Tag # DKMY55 when he arrived to pick up the 2 females. Gaspar allowed one the females who he knows as "Brittany" To drive the vehicle and he sat in the rear with the second female. Gaspar did not know the second female by name but advised that he had sex with her approximately 4 times in the past. He confirmed that he met her Via the Facebook application and confirmed that She had called him via the Facebook Messenger to meet up today. The female "Brittany" drove around and then in the area of 11000 Orange Blvd., pulled over and requested that Gaspar sit in the front passenger seat with her. Gaspar agreed. He exited the vehicle and began to enter the front seat when the driver stomped on the accelerator taking off at a high rate of speed. Gaspar held on to the vehicles Door and was dragged down the street. He estimated approximately 1/2mile. While he was being dragged the second female hit him several times in the face which caused him to let go. 911 calls reflected that the incident location occurred at 11352 Orange Blvd, Loxahatchee Blvd, 33470. Gaspar was transported to Palms West Hospital where he sustained severe road rash through the majority of his body. The 2008 Ford Focus was entered into FCIC/NCIC as stolen. Gaspar provided me with the following suspect description:

- Suspect 1: "Brittany", WF, 5'/130LBs, Black Hair, White Long sleeve Shirt, Blue Jeans.
- Suspect 2 : WF, 5'/130LBs, Purple Hair, Wearing a red Dress.

Gaspar advised that he had the suspects phone number and facebook account on his telephone, which was stolen with the vehicle.

On 03/04/2018, I responded to Gaspars residence where I obtained additional information on the suspects in this case. Gaspar provided me with a detailed digitally recorded statement as to what occurred. For verbatim account, please refer to the actual statement. After being released from the hospital he located the suspects Facebook account by longing into his account. The suspects account reflected a URL of <https://www.facebook.com/Queenn.Leana> . I photographed the Facebook account and confirmed that this was the same suspect who was in the rear seat of the vehicle and punched Gaspar as the vehicle was bring stolen. He confirmed that she was. He also advised that he had a phone number that belonged to the Female" Brittany" but it was inside of his phone. He had never contacted Brittany by telephone.

At approximately 1420hrs I received information that the stolen vehicle was at the Lake Worth Beach, located at 10 S Ocean Blvd, Lake Worth, FL, 33461 Detective Foster And I responded to this location and conducted surveillance. The Vehicle was located parked within the west parking lot of the beach. Within moments of conducting surveillance the vehicle became occupied by 3 WF, all of whom who fit the exact description of the suspects in this case. Detective Foster and I Conducted a Felony traffic stop on the vehicle as the occupants were about to leave. The driver and front passenger immediately exited the vehicle. The driver attempted to flee on foot but Detective Foster held on to her and brought her to the ground. The front passenger refused to comply with any commands after being told to lay on the ground several times. And the rear seat passenger complied with commands and immediately uttered statements to detectives that she didn't steal the car. All subjects were ultimately detained and placed into handcuffs. The subjects were identified as follows:

- Driver: Rebecca Torres WF DOB: 10/13/1996, She was wearing a red hoodie and blue jeans. She had an active warrant for her arrest for FTA.
- Front seat passenger: August Watkins WF DOB 10/16/2000, wearing a gray 2-piece shirt and shorts.
- Rear Seat passenger: Olena Papamichael WF DOB 02/02/1999 wearing dark shirt red jeans. She had active warrants for her arrest FTA Burglary.

All subjects were transported to the Palm Beach County Violent crime division where i conducted digitally recorded video interviews. The first interview I conducted was with Papamichael. Post Miranda she confessed to being involved with the robbery. She stated that Watkins was the driver of the vehicle and Papamichael sat in the rear with Gaspar. Watkins was driving and told Gaspar that if he got into the front passenger seat she would give him oral sex while driving. Gaspar agreed and Watkins pulled the vehicle over. Gaspar exited the vehicle and as he was getting into the front passenger seat Watkins accelerated the vehicle taking off. Gaspar was being dragged by the vehicle and Papamichael advised that Watkins grabbed a knife and stabbed Gaspar in the arm causing him to fall into the ground. Papamichael denied ever striking him in the face.




I then interviewed August Watkin. I read Watkins Miranda from a juvenile Miranda form, which she confirmed that she understood. Post Miranda Watkins denied any involvement. A records check revealed that Watkins is currently on Juvenile probation for Burglary to a Conveyance (2 counts), Illegal Use of a Credit Card and Resist LEO without Violence. The probation start date was 01/22/2018 through the age of 19 or completion of requirements. DJJ confirmed the stated information.

I then interviewed Rebecca Torres. Post Miranda Torres advised that she was picked up by Watkins. Before driving the stolen vehicle, she told detectives that she asked Watkins if the vehicle was stolen because she knew that Watkins apparently drives stolen vehicles. Torres denied knowing that the vehicle was stolen.

## NARRATIVE:

On 03/03/2018 at approximately 1250Hrs, the victim, Edgar E Gaspar Gaspar (WM DOB 07/08/1995) met with 2 females in the area of the Publix supermarket in Loxahatchee FL. The 2 females were known to Gaspar as females who he had prostituted with in the past. Gaspar was driving a 2008 Red Ford Focus Bearing FL Tag # DKMY55 when he arrived to pick up the 2 females. Gaspar allowed one the females who he knows as "Brittany" To drive the vehicle and he sat in the rear with the second female. Gaspar did not know the second female by name but advised that he had sex with her approximately 4 times in the past. He confirmed that he met her Via the Facebook application and confirmed that She had called him via the Facebook Messenger to meet up today. The female "Brittany" drove around and then in the area of 11000 Orange Blvd., pulled over and requested that Gaspar sit in the front passenger seat with her. Gaspar agreed. He exited the vehicle and began to enter the front seat when the driver stomped on the accelerator taking off at a high rate of speed. Gaspar held on to the vehicles Door and was dragged down the street. He estimated approximately 1/2mile. While he was being dragged the second female hit him several times in the face which caused him to let go. 911 calls reflected that the incident location occurred at 11352 Orange Blvd, Loxahatchee Blvd, 33470. Gaspar was transported to Palms West Hospital where he sustained severe road rash through the majority of his body. The 2008 Ford Focus was entered into FCIC/NCIC as stolen. Gaspar provided me with the following suspect description:

- Suspect 1: "Brittany", WF, 5'/130LBs, Black Hair, White Long sleeve Shirt, Blue Jeans.
- Suspect 2 : WF, 5'/130LBs, Purple Hair, Wearing a red Dress.

Gaspar advised that he had the suspects phone number and Facebook account on his telephone, which was stolen with the vehicle.

On 03/04/2018, I responded to Gaspar's residence where I obtained additional information on the suspects in this case. Gaspar provided me with a detailed digitally recorded statement as to what occurred. For verbatim account, please refer to the actual statement. After being released from the hospital he located the suspects Facebook account by logging into his account. The suspects account reflected a URL of <https://www.facebook.com/Queenn.Leana>. I photographed the Facebook account and confirmed that this was the same suspect who was in the rear seat of the vehicle and punched Gaspar as the vehicle was being stolen. He confirmed that she was. He also advised that he had a phone number that belonged to the Female "Brittany" but it was inside of his phone. He had never contacted Brittany by telephone. He also provided me a possible address of where one of the suspects lives. He told me that he dropped them off before by Citrus PI, In Wellington. He was unable to tell me the exact address but showed me on Google Earth that it was possibly the third or fourth house after making the left on Citrus PI.

At approximately 1420hrs I received information that the stolen vehicle was at the Lake Worth Beach, located at 10 S Ocean Blvd, Lake Worth, FL, 33461. Detective Foster and I responded to this location and conducted surveillance. The vehicle was located parked within the west parking lot of the beach. Within moments of conducting surveillance the vehicle became occupied by 3 WF, all of whom fit the exact description of the suspects in this case. Detective Foster and I conducted a felony traffic stop on the vehicle as the occupants were about to leave. The driver and front passenger immediately exited the vehicle. The driver attempted to flee on foot but Detective Foster held on to her and brought her to the ground. The front passenger refused to comply with any commands after being told to lay on the ground several times. And the rear seat passenger complied with commands and immediately uttered statements to detectives that she didn't steal the car. All subjects were ultimately detained and placed into handcuffs. The subjects were identified as follows:

- Driver: Rebecca Torres WF DOB: 10/13/1996, She was wearing a red hoodie and blue jeans. She had an active warrant for her arrest for FTA.
- Front seat passenger: August Watkins WF DOB 10/16/2000, wearing a gray 2-piece shirt and shorts.
- Rear Seat passenger: Olena Papamichael WF DOB 02/02/1999 wearing dark shirt red jeans. She had active warrants for her arrest FTA Burglary.

I requested that road patrol seal the stolen vehicle and transport it to the Palm Beach County Sheriff's Office impound lot.

All subjects were transported to the Palm Beach County Violent crime division where I conducted digitally recorded video interviews. The first interview I conducted was with Papamichael. Post Miranda she confessed to being involved with the robbery. She stated that Watkins was the driver of the vehicle and Papamichael sat in the rear with

Gaspar. Watkins was driving and told Gaspar that if he got into the front passenger seat she would give him oral sex while driving. Gaspar agreed and Watkins pulled the vehicle over. Gaspar exited the vehicle and as he was getting into the front passenger seat Watkins accelerated the vehicle taking off. Gaspar was being dragged by the vehicle and Papamichael advised that Watkins grabbed a knife and stabbed Gaspar in the arm causing him to fall into the ground. Papamichael denied ever striking him in the face.

I then interviewed August Watkin. I read Watkins Miranda from a juvenile Miranda form, which she confirmed that she understood. Post Miranda Watkins denied any involvement. She confirmed that her local address is 951 Citrus Pl, Wellington, FL. A records check revealed that Watkins is currently on Juvenile probation for Burglary to a Conveyance (2 counts), Illegal Use of a Credit Card and Resist LEO without Violence. The probation start date was 01/22/2018 through the age of 19 or completion of requirements. DJJ confirmed the stated information.

I then interviewed Rebecca Torres. Post Miranda Torres advised that she was picked up by Watkins. Before driving the stolen vehicle, she told detectives that she asked Watkins if the vehicle was stolen because she knew that Watkins apparently drives stolen vehicles. Torres denied knowing that the vehicle was stolen.

Based on my investigation I found PC Exists for the following:

- Rebecca Torres for Grand Theft Motor Vehicle FSS 812.014(2C6), Resisting LEO w/o violence FSS 843.02, and FTA Warrant reference warrant # 16018013CTAXX
  - August Watkins for Resisting LEO w/o Violence FSS 843.02, Violation of probation FSS 985.101
  - Olena PapaMichael for Carjacking FSS 812.133(2B), Aggravated Battery with a deadly weapon FSS 775.087(1A), FTA warrant under Warrant # 17004999CFAXX
- District 1 road patrol deputies transported Watkins to the Juvenile assessment center. They also transported Torres and PapaMichael to the Palm Beach County Jail Without incident.

Watkins Cellphone was recovered and placed into PBSO Evidence.

As routine procedure I conducted a background check on Gaspar, Nothing of evidentiary value was discovered.



On 03/06/2018 Crime Scene investigators responded to the PBSO impound lot and assisted me in processing the victims vehicle. Inside of the vehicle we located 3 Purses. A Tan purse on the drivers side rear seat (claimed by PapaMichael), A black purse on the front drivers seat (Claimed by Torres). A black designer purse on the rear seat passenger side (claimed by Watkins). Inside of the purse belonging to Watkins, I located the owner of the vehicles credit card within one of the pockets. In the vehicle was a lot of clothing from the Retail store Ross. I did not locate any receipts or store bags for these items.

At approximately 1150hrs I responded to Gaspar's residence for follow up investigation. I requested that D/S Gomez ID 6983 respond to assist in showing a photo array to the victim. I complied an array containing Watkins along with 5 other randomly selected individuals who appear to have similar characteristics. They were randomly placed into a lineup in no particular order. D/S Gomez showed Gaspar the photo array. The encounter was captured on a digital recorder. For verbatim account, please refer to the actual statement. I was advised that Gaspar immediately identified the person selected in position #1 as the suspect driver during the robbery. The person placed in position number 1 is August Walkins. After the photo array was completed, I spoke with Gaspar asking him about the possibility of a knife being used. He confirmed that the suspect Watkins was playing with his utility knife, which was in the center console of the vehicle. I photographed his injuries which appeared to be scratch marks possibly from a dull knife attempting to cut him. Gaspar could not confirm whether the knife was used or not.

Based on my investigation I found PC Exists for the arrest of August Watson for Carjacking FSS 812.133(2B), Aggravated Battery with a deadly weapon FSS 775.087(1A).
