On 7/15/17 at approximately 0135 hours, Officer Fong and I were dispatched to 299 SW 7th ST Apt 205 in reference to a noise disturbance and a possible domestic disturbance.  On arrival we made contact at apartment 205; it should be noted that while outside of the apartment we heard loud music and a lot of screaming coming from inside, it sounded like an argument was occurring inside. A W/F later identified as Aurora T Mourra Churchill opened the front door. When she opened the door we noticed that Mourra's face was red and her eyes were watery, in the background we saw a W/M later identified as Steven Churchill. Churchill was cursing and screaming and he appeared to be under the influence of alcohol.  I asked Mourra if we could come in and she stated "you're not coming in without a warrant" and she slammed the front door. Officer Fong and I called for additional backup units, while waiting in the hallway we heard Churchill screaming saying he was leaving and he then said "fuck this I am leaving." We noticed that Churchill was forcing open the kitchen hallway door. I told officer Fong that I will detain Churchill (who is a possible suspect) when he comes out in order to conduct a domestic disturbance investigation. This was due to how belligerent Churchill was acting and to prevent him from leaving becuase we thought that he had possibly struck Mourra in her face (due to her redness on her face.)  Churchill proceeded to come out through the kitchen hallway door, I grabbed his right arm and placed it behind his back and I told him that he was being detained and I attempted to handcuff him. This was done is order to prevent him from leaving. Churchill pulled away from me and we ended up in the kitchen. Officer Fong came into the kitchen in an attempt to help me place Churchill into custody (for further see officer Fong supplement.)


While in the kitchen Churchill pushed me away (in the shoulder) while I was attempting to place him in custody, at which point I told Churchill that he was under arrest. At this point we were still not able to place Churchill into custody. I told officer Fong to back off and I took out my department issued taser and I deployed the taser in Churchill's stomach area (he was facing me.) Officer Fong took Churchill down to the ground (see his supplement for further) and I grabbed Churchill's left arm to help officer Fong handcuff him.

While I grabbed Churchill's left arm, I felt that I was being pulled from behind. I turned around and I saw that it was Mourra. I turned towards Mourra and I told her that she was under arrest. Mourra began to yell while I grabbed her left arm to take her into custody. While I attempted to place Mourra's right arm in the handcuffs she pushed me and she grabbed my left bicep and scratched me. Officer Fong came and took Mourra into the hallway and took her down to the ground.

Boca Raton Fire Department responded and they transported Churchill to BRRH (FD run# 17-9374.) Mourra was transported to BRPD for booking by Officer Calhoun.

While at the residence I spoke with Edward Hanford (step father) he filled out a written statement (submitted into evidence.) Ana Hanford was also on scene but she refused to write a statement. Alexis Hanford (13 years old) was on scene and she advised that she just observed a verbal altercation between Churchill and Mourra. Officer Chriswisser who was on scene notified DCF of the altercation between the family members. Ana and Edwards also advised that the argument between Mourra and Churchill was only verbal.

Churchill and Mourra were both ultimately transported to Palm Beach County Jail and they were charged for Battery on a Law enforcement officer under F.S.S 784.07(2B) and Resist arrest with violence under F.S.S 843.01.
