The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 24 day of February, 2018 at 23:45

On 02/24/18, at approximately 2345 hours, I arrived at 1203 Town Center Dr (Jumby Bay Bar), in reference to a physical fight in progress. I was driving a marked Jupiter Police patrol vehicle and dressed in a full Jupiter Police patrol uniform.

I arrived on scene and the fight had ended. There were several intoxicated patrons outside the business. An employee, WM Ryan Skelton, flagged me down, and pointed out Longwell. Skelton stated Longwell has been a problem in the past.

I walked over to Longwell and told him to walk towards me. He was standing outside near several other intoxicated subjects. I did not want to walk in the middle of all the intoxicated subjects, so I told him to walk towards me.



comply with my lawful orders, he was placed into handcuffs. At this time, I had probable cause to arrest Longwell for disorderly intoxication and resisting an officer without violence. Longwell was transported to the Jupiter Police Department for paperwork and then to the county jail without incident. He was also advised of his indefinite trespass warning from Jumby Bay.

Based on statements, evidence, and my investigation, I find probable cause to believe that Austin G. Longwell was intoxicated and endangered the safety of other people, causing a public disturbance, contrary to FSS 856.011 (Disorderly Intoxication).

Based on statements, Longwell's actions, and my investigation, I find probable cause to believe that Austin G. Longwell did resist, obstruct, and opposed me, an officer with the Jupiter Police Department, in the lawful execution of my legal duty without offering violence, contrary to FSS 843.02 (Resisting an Officer without Violence).
