## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)  
Driver was observed travelling well over the posted speed limit and driving carelessly. During the traffic stop the driver struck the curb stop while pulling into the parking spot. Traffic stop was conducted by K9 Officer Kimbark. For further, see Officer Kimbarks supplemental report.

## OBSERVATION OF DRIVER:

Upon making contact with the Early, i noticed the strong odor of an unknown alcoholic beverage coming from his person. Early had red bloodshot glassy eyes and was unsteady on his feet, using his arms for balance multiple times. Early's demeanor fluctuated throughout the interaction, being aggressive, then apologetic, confused, and forgetful. He also used abusive, sarcastic, and insulting language.

## DRIVER'S STATEMENTS:

Driver made many abusive and insulting statements. Early stated that he shouldn't be driving, and he does not drink and drive. He tried to joke with officers on scene and called us "fucking dicks" multiple times. He was given instructions multiple times, and after forgetting them, accused officers of never giving the instructions and then becoming upset.

Odor of an unknown alcoholic beverage coming from his person.

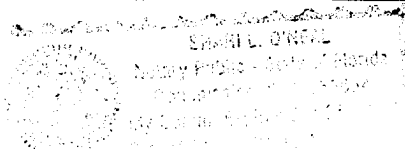

Early was using his arms for balance while standing still and failed to listen to instructions multiple times, before and after the completion of tasks.

**WALK & TURN:**

Early stated that he understood the instructions, but interrupted them multiple times. He did not remain in the start position. Early stated, "i couldn't do that if", but did not complete the sentence. He and also stated that he was getting too cocky and that he is a "fucking idiot". Early used his arms for balance on the back 9 steps. He took the improper amount of steps on the back 9 steps.

**ONE LEG STAND:**

Early stated he understood the instructions, but interrupted during instruction period. Early did not follow the instructions. He started the task before being instructed to start. Early was swaying while completing the task. He did not count as instructed.

**FINGER TO NOSE:**

Early stated he understood the instructions and started before being instructed to do so. Early initially missed the first left finger to nose. One right completed, two left completed, two right completed. During three right, Early began bringing up his left hand but then corrected and brought up the correct hand. Three left, completed.

**ROMBERG ALPHABET:**

Early stated he understood the instructions. Alphabet was completed extremely slowly and paused multiple times during the task.

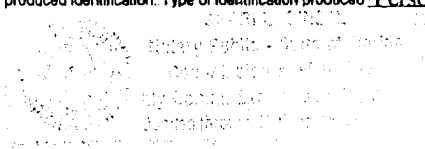

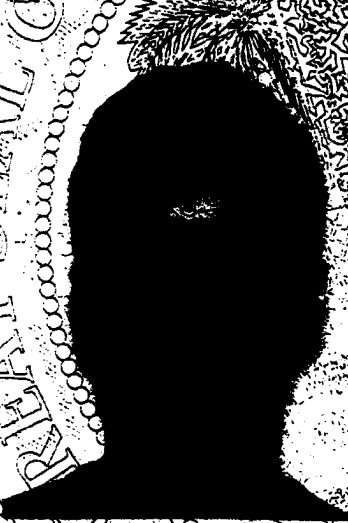
