<p>The following occurred in unincorporated Loxahatchee, Palm Beach County, Florida:</p> <p>On the above date and time, I was on road patrol driving my fully marked patrol vehicle, asset number #78187, when I observed a dark colored 4D Pontiac driving excessively over the posted speed limit of 45 mph, driving northbound on Seminole Pratt Whitney RD. I proceeded to follow the Black/Blue 4D Pontiac Bonnaville, bearing FL Tag 1ZCL36. I also paced clocked the vehicle at 73 mph within the posted limit of 45mph. I initiated a traffic stop at the location of Seminole Pratt Whitney Rd and W Sycamore Dr.</p> <p>During this time I viewed clearly, that the driver was reaching over towards the passenger area front seat and at this time I could no longer see the driver and the driver was making furtive movements towards the right side, possibly to conceal something. I could not view the drivers head or upper body through the back glass of the vehicle. At this time I viewed the drivers door was slightly opening and at this time I made commands to the driver and occupants of the vehicle to stay in the vehicle, and at this time the drivers door closed.</p> <p>During this time the driver reappeared from the prior furtive movement and from leaning down from under the passenger seat area. At this time I viewed more excessive movement from the driver and passenger of the vehicle and what appeared to me a hand to hand transaction.</p> <p>At this time I made contact with the driver, later identified by his FL DL to be Austin Kurt Vanderplate (D.O.B 05/18/1999). During this time Vanderplate was showing signs of extreme nervousness. I explained the reasons for my investigation for the traffic stop. Due to the excessive furtive movement from Vanderplate during the traffic stop and the extreme disoriented behavior, I had Vanderplate to exit the vehicle.</p> <p>I conducted a systematic search of the vehicle. During the search, I discovered what appears to be a green colored electronic vape pen under the passenger front seat area. I also discovered a black electronic vape pen under the rear passenger bench seat area. Both vape pens contained a dark yellowish color liquid oil substance inside.(viewed through the clear glass).</p> <p>I collected the two Vape e-cigarette pens and used a duquenois test kit on the amber colored oil. The oil Field tested positive for THC. The substance which also test yielded a positive reaction (turning purple in color).</p> <p>Austin Kurt Vanderplate was placed under arrest for the possession of a controlled substance per F.S.S. 893.13(6)(A)</p>
