On 01/04/18, at approximately 2013 hours, I responded to 3100 S Dixie Hwy (Apt G75), in reference to a domestic disturbance.

I met with Adam Reiser in front of the residence. Adam advised that he had an argument with his brother, Austin Reiser, over an item that was sold on an application called Offer Up. Adam advised that Austin wanted \$100 share of the money earned from the sale. Adam stated that he would not give Austin the \$100. Adam stated that at that time, Austin became angry and kicked the wall. Adam advised he left the residence to let Austin cool down. Adam advised when he returned about 20 minutes later, he found that his "goal" card (piece of paper with personal goals) was ripped up. Adam walked into Austin's room to ask him about the goal card. Adam stated Austin spit in his face and then walked into the bathroom located inside the bedroom. Adam walked into the bathroom after Austin, and Austin had a steak knife in his right hand. Austin stated, "If you punch me, I will stab you." Adam stated he was afraid and quickly left the room. Adam stated he then went to the kitchen and took all of the knives out of the kitchen and put them into his car so that Austin did not have access to anymore knives. Adam advised that he never threatened Austin with a knife at any point during the confrontation.

I then met with Austin Reiser. Austin advised that he received a notification through Offer Up that an item was sold. Austin advised he confronted Adam about the item that was sold. Austin stated that he got angry and kicked the wall, at that point Adam left the residence. When Adam left the residence, Austin took Adam's "goal" card and ripped it up. Austin advised that when Adam returned to the residence, he walked into Austin's room and stated, "I'm going to kick your ass". Austin stated that he spit in Adam's face. Austin said he then walked into his bathroom and picked up a knife because he was afraid Adam was going to "kick his ass". Austin advised he told Adam, "If you come near me, I am going to start swinging this at you." Austin advised that Adam left the room and returned with two knives and pushed him against the wall, holding the knives to his
