On the **26** day of **July**, **2014** at **00:00** (Specifically include facts constituting cause for arrest.)



The Following took place in the City of Delray Beach, Palm Beach County Florida.

On 7/31/2014, the reporting party, Traci McGuire, reported her son`s (Matthew Schmidt) black, 2014 Taizhou Zhongneng (FL tag# 1860NU, VIN# L9NTELDK0E100986) stolen from the driveway of his residence (1104 NE 3rd Ave). She further stated that she went to retrieve the scooter for her son on 7/26/2014 and it was no longer at the residence. It should be noted that Schmidt is currently living in a half-way house with many other residents. At this time there was an Attempt to Locate report generated due to Schmidt being unavailable.

On 8/1/2014, I made contact with the house manager who advised that one of the other residents (Grace) had witnessed the theft. I attempted to contact Grace, but she was out of the area and stated that she would meet me at the Delray Beach Police Dept. on 8/11/2014.

On 8/7/2014, Schmidt came to the Delray Beach Police Dept. and reported his scooter stolen. At that time Schmidt filled out a Palm Beach county Vehicle Theft Affidavit swearing he gave no one permission to operate his scooter. The scooter was then entered into NCIC/FCIC as a stolen scooter.

On 8/11/2014, I met with both Matthew Schmidt and Grace Ozolnieks in the Delray Beach Police Dept lobby. At that time Schmidt told me that he was two weeks late checking in with his Probation Officer and was violated. He further explained that he was arrested on 7/3/2014 and transferred to Sarasota county Jail on 7/24/2014. Prior to being violated he left his scooter with the steering column locked and parked behind a fence on the side of the residence located at 1104 NE 3rd Ave. It should be noted that the keys to the scooter are in Schmidt`s possession.



I then spoke with Grace who stated that on 7/26/2014, Austin Thrash [REDACTED] told her they were going to "hot wire" Schmidt's scooter. It should be noted that at the time Thrash [REDACTED] were also residing at 1104 NE 3rd Ave. She went on to state that after she told them not to do it, they went outside anyway. Ozolnieks stated that a after a few minutes she looked out the window and saw Thrash [REDACTED] "hot wiring" the scooter. She then stated that approximately 20 minutes later she saw them, "riding the scooter up & down the road". Ozolnieks stated that on 7/27/2014, Thrash stated that he was going to sell the scooter to a drug dealer only known to her as "Vick". After telling him, "Please don't do it you are gonna go to jail". Thrash [REDACTED] rode away on the stolen scooter only to return approximately, "45 minutes later with no scooter and drugs". It should be noted that Ozolnieks knows both Thrash [REDACTED] and was able to verify that the two suspects she saw "hot wire" the scooter are the same two individuals that were on the photos provided by the house manager.

Based on the above stated facts, I find Probable Cause exists to charge Austin Thrash and [REDACTED] as they and did knowingly obtain or use, or endeavor to obtain or use the black, 2014 Taizhou Zhongneng scooter of a value of \$1,700.00 or more, which was the property of Matthew Schmidt, or any other person not the defendant(s), with the intent to permanently or temporarily deprive Matthew Schmidt or any other person not the defendant(s) of the property or benefit therefrom or to appropriate the property to the use of Austin Thrash [REDACTED] or to the use of any person not entitled thereto, contrary to Florida Statute 812.014 (2) (c) (6).
