NARRATIVE:

I responded to 10300 Forest Hill Blvd in the village of Wellington, Palm Beach County, FL 33414 at the Mall at Wellington Green in reference to a missing child. Upon arrival, I learned that nine month old Israel Williams was taken by her biological mother, Autumn Williams, during a supervised visit. According to court case #2016DP000277JS, Israel was placed in the temporary custody of the Florida Department of Children and Families(DCF) in out of home licenced care on June 23, 2016. It should be noted that Israel was born June 3, 2016 and was placed in the Neonatal Intensive Care Unit (NICU). On June 22, 2016, Israel was taken into custody by the DCF Child Protective Investigator (CPI).

DCF Family Support Worker, Shaffrayn Mendoza, supervises visits between Autumn and Israel every Wednesday from 1-3pm. These supervised visits have been occurring since DCF took custody of Israel. They meet at different public locations and today, 2/22/17, they met at the Mall at Wellington Green. Shaffrayn picked Israel up from daycare in Loxahatchee and when she arrived at the mall, Autumn was already waiting in the food court. Shaffrayn stated Autumn was quieter than usual and seemed upset. Shaffrayn went to the bathroom for a few minutes and when she returned, Autumn and Israel were gone. Shaffrayn attempted to call Autumn several times and went to look for them before calling PBSO.

NARRATIVE CONTINUATION

While I was at the mall, Sgt. Bradford, who was coordinating location efforts from the Palm Beach Sheriff's Office, made contact with Autumn's sister, Ashley. Ashley stated she had Israel with her and she was in a cab heading to her father's house in Broward County because she thought she was supposed to bring her there to meet with detectives. Sgt. Bradford asked her to turn around and meet us in Boca Raton. Ashley and Israel made contact with PBSO deputies at 1311 W Palmetto Park Rd in the city of Boca Raton. Israel appeared unharmed and healthy.

I responded to 1311 W Palmetto Park Rd and made contact with Ashley. She stated she received a phone call from her father saying that Autumn took the baby and she could be in a lot of trouble. Ashley called Autumn and convinced her to return Israel. Ashley stated Autumn left Israel with a friend who brought Israel to Ashley. Ashley thought she was supposed to turn Israel over to detectives at her father's house in Broward county. Her father put her in contact with Sgt. Bradford who asked her to turn around and meet with deputies in Boca Raton where she ultimately turned Israel over to DCF employees.

At approximately 9:00pm, I made contact with Autumn at 3798 NE 4th Ave in the city of Boca Raton. I read Autumn her Miranda Warnings from a prepared PBSO Miranda Warnings card. Autumn stated she understood each warning and signed the card. Autumn told me her child, Israel, was removed by DCF when she was born because she had opiates in her system at birth. Supervised visits with Israel and DCF began when Israel was around three weeks old. She has had supervised visits every Wednesday from 1-3pm at different locations.


Today, 2/22/17, Autumn met Shaffrayn and Israel at the Mall at Wellington Green. Autumn was upset because Israel had a cold and she feels that she is always sick. Autumn was also upset because she knows the time is coming when Israel could be adopted and she was afraid she would not get her daughter back. When Shaffrayn went to the bathroom, she panicked and left with Israel. She stated her sister's boyfriend, Teddy Evans, drove her to the mall for her visit. She exited the mall with Israel and went to his car to wait for him. When he returned to his vehicle, she told him DCF released Israel to her.

While traveling southbound on I-95, Teddy received a phone call from Autumn's mother letting him know that she took Israel and the police were looking for her. They ultimately called Ashley and dropped Israel off with her. When she dropped Israel off, she left on her own and went to a friend's house. She does not know where Teddy, Ashley and Israel went. She stated she did not have a plan when she took Israel but knows it was wrong.

NARRATIVE CONTINUATION

Based on the above information, I find that Autumn Williams did without lawful authority, knowingly or recklessly take, entice, aid, abet, hire, or otherwise procure another to take Israel Williams, a child 17 years of age or under from the custody of the child's parent, guardian, or public agency having the charge of said child, or any lawful custodian, contrary to Florida Statute 787.03(1). (3 DEG FEL) (LEVEL 4)
