In the City of Riviera Beach, Palm Beach County Florida, the following occurred:

The following incident was captured on my department issue Axon 2 Body Camera.

On Wednesday, July 24, 2019 at approximately 12:00pm I was dispatched to 709 Wedgewood Plaza Drive in reference to a Simple Battery (Domestic). Upon arrival, I made contact with Autumn Frances who advised that her and her boyfriend Jacob Busey had just gotten into a physical altercation after an argument over Mr. Busey's wallet being lost. Ms. Frances advised she and her roommate Vanessa Torres were walking her dog when Mr. Busey approached them near the community lake and stated "we" lost his wallet. Ms. Frances said that she didn't want to argue over who lost Mr. Busey's wallet, returned to the apartment and tried packing some belongings to leave the residence. Mr. Busey continued to put Ms. Frances' belongings back into their room after she brought them outside which further agitated Ms. Frances.

According to Ms. Frances, Mr. Busey locked her items in their room and allegedly stood by the bedroom door trying to speak with her. The argument continued by the front door, and Ms. Frances advised Mr. Busey stood by the front door in an attempt to stop her from leaving the residence. Ms. Frances advised that's when she jumped on Mr. Busey's back and struck him as they wrestled on the ground after he slammed her. Ms. Frances stated she hit Mr. Busey in the face and was pulling his hair because she allegedly couldn't exit out the front door. Ms. Frances added that Mr. Busey even grabbed her by the neck. Note: there were no visible marks on Ms. Frances' neck to support her allegation.

Ms. Frances then immediately changed her story and stated that she threw an unknown item of Mr. Busey's against the wall and broke it which caused him to suggest breaking some of her personal items. Ms. Frances stated that Mr. Busey walked over to some of her personal items on the living room shelves, which caused her to jump on his back. In the

second story, Ms. Frances advised that Mr. Busey never block the front door or stopped her from calling the police. Ms. Frances confirmed she didn't try to leave because her personal items were inside the apartment.



Ms. Frances admitted to knowing she could have called the police, but she didn't feel that was necessary because they frequently fight. Ms. Frances was observed with cuts on her hand and blood on her arms and pants.

I then met with Mr. Busey who stated that he confronted Ms. Frances about his wallet missing. He also said the argument continued inside their apartment, and that he "ran into the door three times." Mr. Busey stated he didn't want Ms. Frances to go to jail and refused to provide further details about the case. Mr. Busey later admitted Ms. Frances jumped on him.

I observed blood on Mr. Busey's hands, arms and chin. Mr. Busey and Ms. Frances refused medical attention on scene. Photographs were taken and placed into evidence along with all recorded statements.

Ms. Torres stated that she only heard Mr. Busey and Ms. Frances arguing by the front door as Ms. Frances was trying to leave.

Mr. Busey was provided a Victims Right's Brochure referencing case number 19-05094.
