I responded to 14025 Veronica Ct. located in the Village of Wellington in reference to a domestic disturbance between separated husband and wife, whom have 3 children in common.

Upon arrival, I made contact with a white male who identified himself as Andrew Nadal. He stated his current wife, Azaria Nadal, and him have been married for approximately 7 years and have been separated for the last year. He stated they have 3 children in common. Andrew stated Azaria went to the gym this evening and while she was gone, he went through her belongings and found a men's t-shirt buried beneath her belongings. He stated that he confronted her about the men's garment and was met with hostility. He stated as he removed himself from the situation and went to their bedroom, Azaria followed and slapped him with an open hand without his permission. He stated she struck him in the face below his left eye. Andrew stated he was shocked by the slap and did not know what to do. He stated he then got in her face and then she turned and ran out of the residence to call 911. While speaking with Andrew, I noticed the discoloration on his left cheek where he stated he was slapped. He stated he would complete a sworn written witness statement and would allow me to take photographs of his face.

After speaking with Andrew, I spoke with Azaria Nadal outside. She stated she was at the gym and met with hostility as she walked in the front door by her husband. She stated he found her female friend's pajama shirt in her clothes pile and began to yell at her. She stated she did not remember slapping Andrew in the face and stated he grabbed her and pushed her out of the residence. Azaria did not have any physical marks on her body to parallel her story and what she was accusing. She stated her right hand hurt due to him grabbing her, but she did not have any physical injuries to her person. She also refused to take photographs and refused to write a statement.

It was at this point where I had enough probable cause to arrest Azaria Nadal for domestic battery, violating FSS 784.03(1)(a).

She was placed in handcuffs which were checked for tightness and double-locked. She was then consequently transported to the Western Detention Center without any incident.
