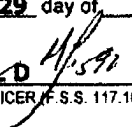

	the same neighborhood. Escobedo continued, stating that she lives in the apartment complex and her ex lives next door. She stated that she got into a fight with her boyfriend because he is jealous, and he asked her to go inside the house. Escobedo stated that she told him that she was not going in the house and Damian grabbed her by the neck with both hands. I asked to look at Escobedo's neck and I observed no marks or bruises that would be consistent with her statement. Escobedo stated that her boyfriend then tried to hug her and told her "its ok, I love you mami." I asked her if she put her hands on Damian at any point and she stated yes, because she was on the floor and trying to get up. I asked Escobedo what the dynamic of her relationship with Damian was and she was stated that they share a child together and have been together for 3 years. I then made contact with Damian and asked him what happened. He stated that he thought it would be nice to have a few drinks and spend time with his girlfriend and her mother who was visiting. Damian further explained that Escobedo became drunk and went outside to smoke a cigarette. He followed her and asked her to come inside the house. Escobedo then became upset and went back inside. While inside of the apartment, Escobedo became increasingly upset stating that she can do "whatever the fuck" she wants and told Damian to "get the fuck out of m house." Let it be known that Damian lived in the apartment with Escobedo and their 3 children. Damian continued, explaining that he tried to hug Escobedo to try to calm her down because she was so upset. At that point, Escobedo scratched Damian with her right hand across the upper left to lower right portion of his face. Damian stated that he then backed away and that's when Escobedo called 911. Three children, Christopher Damian (NB), Aricia Nava (9), and Saul Baldera (3), were present during this incident. DCF was notified and operator Kevin #526 advised they will be taking a report. Based on the statements provided by both parties involved, I determined that Escobedo did actually and intentionally scratch Damian against his will and Damian is a household member of Escobedo which they share a child in common. I placed Escobedo under arrest at 0418 hours for violation of Florida Statute 784.03(1) Domestic Battery. The handcuffs were double locked and finger checked for tightness. Escobedo was placed in the right rear seat of my patrol vehicle and transported to BRPD for processing. Escobedo was turned over to Palm Beach County Jail for booking.

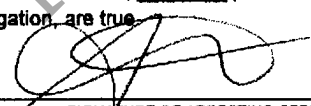
