

On July 21, 2017 at approximately 11:57 A.M. I was dispatched to the residence of 2368 Seminole Blvd. West Palm Beach FL 33409 in reference to a delayed domestic dispute. Upon my arrival I made contact with a white female who identified herself with a Florida Driver's License as Ashley Marie Kosek, date of birth 07/14/1985. Kosek was accompanied by her two children by the names of Ariana Delvalle (W/F 04/21/2009) and Liam A. Sadiq (W/M 06/06/2014). Kosek was crying and told me in a sworn taped statement that her boyfriend by the name of Babur "Bobby" Sadiq woke up this morning at approximately 11:00 A.M. and confronted her about Kosek taking the children to see her family last week. Kosek stated that Sadiq threatened to have cameras all around the house to monitor her leaving the house with the children. Kosek stated that Sadiq then grabbed her by the arms and pushed her to the ground. When Kosek attempted to call police, Sadiq grabbed the cell phone out of her hand, proceeded to grab other cell phones and an I-pad in an attempt to stop Kosek from calling police. Kosek stated that Sadiq gave Kosek the phone after at least 30 minutes had passed and when Sadiq left the house to go to work. Kosek told me that Sadiq begged her not to call police. Kosek told me that she was very scared of Sadiq's anger towards her and was afraid of Sadiq returning to the residence. Kosek had no marks, cuts, bruising or swelling on any areas of her exposed body and did not appear to be under the influence of drugs or alcohol.

I made contact with Ariana Devalle (W/F 04/21/2009). Devalle stated in a taped sworn statement that she observed Sadiq push Kosek to the ground and only heard Sadiq take the cell phone away from Kosek. Devalle stated that she heard her mother (Kosek) tell Sadiq that she was calling police because she was scared. Devalle stated that she observed Sadiq with all of the household's electronic devices in his hand

I made contact with Babur Sadiq. Sadiq stated in a post-Miranda taped statement that he denied placing his hands on Sadiq in any way whatsoever. Sadiq stated that he only took possession of the cell phones because he was leaving the house and he owned the phones. Sadiq had no marks, cuts, bruising or swelling on any areas of his exposed body and did not appear to be under the influence of drugs or alcohol.
