This incident occurred in the City of Delray Beach, Palm Beach County FL.

On 7/14/18 at 6:43 PM I was dispatched to 1010 NE 8th Ave in reference to a disturbance. I made contact with the complainant, Keith Frader, who stated that one of the residents, later identified as Balasuresh Bastiampillai, was causing a disturbance at the community pool. Keith stated that Balasuresh was intoxicated and was cursing at other residents at the pool. I made contact with Balasuresh and advised him that Officers were called due to him causing a disturbance by yelling and trying to physically fight other residents. Balasuresh stated that he was angry with the other residents over vulgar names that he was being called by residents in the past. While talking to Balasuresh, I observed all the occupants in the pool stop what they were doing and focused there attention to Balasuresh. Also I observe some occupants leave the pool area. A resident on scene, Christopher Wotton, stated that Balasuresh arrived at the pool and began to make verbal threats towards the other occupants in the pool. Wotton stated that Balasuresh also made verbal threats to physically harm the occupants. I attempted to get Balasuresh to leave the pool area and to go back to his residence due to his behavior but he continued to ignore me. At one point Balasuresh began leaving the pool area but then stopped and started to argue with residents. I then commanded Balasuresh to leave the pool area or he will be arrested for disturbing the peace in which he refused and stated "arrest me".

Based on the aforementioned probable cause exists to charge W/M Balasuresh Bastiampillai with one count of Disturbing the Peace per F.S.S. 877.03.
