Sworn Witness observed a Nissan SUV jerk to the left and strike the right of a sedan. The sedan stopped but the Nissan began to speed away. The Nissan was driving erratically and having difficulty maintaining a single lane. The Nissan struck the curb on the right side of the roadway numerous times. As the vehicle approached an intersection it began to drive in the shoulder and almost struck pedestrians that were crossing the roadway. Nissan turned into 100 Portofino Cir and stopped at the guest gate keypad. The female driver stayed in the drivers seat and continued entering numerous wrong codes. Police observed female in same location.

**ROMBERG/ALPHABET:**


Driver did not follow instructions and said the complete alphabet fast and rhythmically.
