On the 24th day of MARCH 20 18 at 02:55 A.M P.M (Specifically include facts constituting cause for arrest.)

On March 24th at approximately 02:53 AM while conducting a close patrol at Lake Park Marina I heard a loud noise coming from a vehicle traveling south on Lake Shore drive approaching my marked PBSO patrol car. As The headlights came around the corner at a high rate of speed. I could see that the driver's front tire was completely flat and causing the noise I heard. The driver continued at a high rate of speed and abruptly slammed on the breaks going through the stop sign into the roadway. Based on the running of the stop sign and driving on a flat tire, I pulled out to initiate a traffic stop. As I passed the stop sign to travel south, the vehicle accelerated at a high rate of speed in the posted 30 mph zone. I estimate the vehicle traveling in excess of 65 miles per hour. There are several speed bumps on the road which the driver never slowed for. I was able to catch up to the vehicle almost a half mile down the road and conducted my traffic stop. I made contact with the driver who did not have his drivers license in his possession. I positively identified him through DAVID as Benjamin Rountree. As I spoke to Benjamin his speech was slurred and a strong aroma of an alcoholic beverage could be smelled coming out of his drivers window. He seemed confused about basic questions as to where he lived and lacked focus. Rountree was the sole occupant of the vehicle. I explained the reason for my traffic stop and Rountree was surprised of the flat tire, he said he did not know it was flat. The tire had several large holes in the sidewall. Rountree freely stated he was driving home from taking out clients for dinner at Guanabanas Restaurant in Jupiter and then to a Martini Bar. He stated he was the designated driver. Due to the above observations a PBSO DUI unit was summoned over the radio to respond. I stood by while roadside tasks were performed. This is a supplemental probable cause affidavit, nothing further to report.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Was observed driving a maroon Ford Fusion on Lake Shore Drive in the city of Riviera Beach Florida by Deputy Jaques #23160 operating his vehicle on a flat left front tire. He performed a traffic stop on the vehicle as it was in operation at the intersection of Lake Shore Drive and Wilma Drive. After making contact with the driver and sole occupant of the vehicle he requested that I respond to determine his ability to operate a vehicle safely. Deputy Jaques provided a sworn affidavit detailing his observations.

OBSERVATION OF DRIVER:

As I arrived I observed the driver standing near the drivers side of the vehicle. Meeting with Deputy Jacques he explained that the driver was operating on a obviously flat tire and upon stopping him he smelled the odor of a alcoholic beverage about his person. Making contact with the driver I identified him verbally as Benjamin Rountree. Rountree spoke in slurred speech and was very unsteady on his feet. He swayed while standing stationary and despite being approximately three to four feet away I smelled a profuse odor of a unknown alcoholic beverage coming from him.

While speaking with him he began to urinate upon himself soaking his right pant leg and front of his jeans. He advised he had to pee urgently therefore he walked to the front of his vehicle and began to urinate.

DRIVER'S STATEMENTS:

I cant do this even if I was sober.

ODORS:

Distinct and profuse smell of a unknown alcoholic beverage coming from his person.

Other Observations:

Angle of onset at 35 degrees. Vertical nystagmus present. Lack of convergence present. Distinct sway while standing stationary. Had to be reminded to keep head still.

WALK & TURN:

Unable to maintain the instructional position. The task had to be explained and demonstrated numerous times for his understanding as he continued to forget how to perform it. After placing him back in it numerous times he attempted to start the task too soon and had to be stopped. Finally starting the task the proper way he walked twelve steps forward contrary to the instruction of nine while raising his arms and stumbling on occasion. He did not turn as instructed and failed to return down the line as instructed.

ONE LEG STAND:

He displayed a distinct sway while standing stationary. Starting the task he failed to keep his foot elevated or the duration of thirty seconds stopping prematurely forgetting the length of time I instructed him the task would last. While his foot was elevated he stuffled for balance and raised his arms.

FINGER TO NOSE:

He displayed a distinct sway while standing stationary. Starting the task he continued to move his hands on his own despite being instructed that I would tell him which had to use. After moving his hands numerous times he looked foward and opened his eyes stopping the task.

ROMBERG ALPHABET:

He displayed a distinct sway while standing stationary. Starting the task he failed to state the alphabet without signing or rhyming it as instructed.
