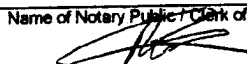
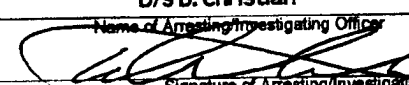

A crash involving injuries was called out at Lake Blvd. and Military trail. The crash involved a white BMW mini and a Chevy pick up truck. Palm Beach County Fire Rescue #42 run number 19-15531 transported the passenger of the Chevy to Delray Memorial hospital for injuries. Upon my investigation the driver, Robert J. Siegfried and passenger, Michael Garafola of the Chevy advised that a white Mini cooper ran the red light and hit the side of the truck. In the intersection was liquid and debris. I collected the silver plastic molding from a front head light along with small pieces of plastic. Robert advised that the driver of the Mini Cooper was a white female, blond hair, wearing a white shirt and black workout pants. The Female ran to his truck and said she didn't have a phone and had to get to work and let people in. She then left the area. As the female drove away, Robert took a picture of the cars license plate. I ran the license plate and discovered the plate had been replaced and the registered owner was the defendant Bernice Theresa Spiller. I attempted to make contact at the listed residence and was met with negative results. At approximately 1100 hours A call for a hit and run crash was called in by the defendant Bernice Spiller. The defendant advised that she was involved in a crash and gave three different locations as to where the crash took place. She advised that she was the only one driving the vehicle this morning and that a white pick up truck pulled front of her. Bernice also advised that the vehicle took off after she hit it. There was no debris in the road way at any of the location Bernice stated the crash took place. She also stated that she had not check on the occupants of the other vehicle because they left the scene. Later Bernice stated that she had a brief conversation with the occupants. Bernice further advised that she had to get to work for her spin class, and called now because the class was completed. At this time the defendant, Bernice T. Spiller is in violation of FSS. 316.027 (1)(A) Accident- leaving the scene- Injury. Bernice was arrested, handcuffed per dept policy and transported to Palm Beach County Jail without further incident.
