

On the 21 day of June, 2017 at 15:18 (Specifically include facts constituting cause for arrest.)

On Wednesday 6/21/2017 at 0521 HRS. I Inv. Daniel Dillard responded to S. Tamarind Ave. and Okeechobee Blvd. which is in the City of West Palm Beach in Palm Beach County. I responded to a traffic crash involving a possible impaired driver. Upon arrival I observed a green Honda Accord (FL Y72MYR) stopped in both Southbound lanes North of the intersection with front end damage. I observed a black Land Rover Range Rover (FL DEHR25) stopped in front of the Honda in the outside Southbound lane with damage to the left rear. I observed a white female sitting in the driver seat, she was later identified as Beth Getsinger by FL DL. I made contact with Ofc. Placeres was holding Getsinger upright as she was unconscious and unresponsive.

I observed the medics remove Getsinger from the vehicle and place her on a stretcher. Her face was pale and her lips were turning blue. The medics placed Getsinger in the back of the ambulance. I asked the medic to open her eyelids and I observed her pupils to be constricted. These indicators were indicative of drug use of Narcotic Analgesics. I observed the medics administer 4 mLs of Narcan to Getsinger. I could see the color restore to her face and the blue fade away from her lips. She also started to wake up and become responsive Getsinger was transported to Good Samaritan Hospital by WPBFR.

I made contact with Ofc. Placeres who was the first officer on scene. She stated Getsinger was unconscious and unresponsive when she arrived on scene. Ofc. Placeres stated she leaned over to check for a pulse and she was able to see down Getsinger's shirt into her bra. She stated clearly visible was a syringe. While having Ofc. Vautin remove the syringe she located 2 capsules next to it which appeared to be heroin.

I made contact with Michael Pike who was driving the Land Rover. He stated he was stopped waiting in traffic at the red light and suddenly felt the impact. He looked behind him and saw Honda behind him and observed Getsinger nod out. He repositioned his vehicle to block the Honda. He got out and knocked on Getsinger's window. She responded

by rolling her window down and proceeded to nod out again. Pike stated at that time he put her vehicle into park and removed the keys from the ignition.



I made contact with Tyler Acham who was the front seat passenger in the Land Rover. He provided the same statement as Pike with the exception of him walking to the passenger side of the vehicle.

I made contact with Amy Hinkler who was the right side rear passenger in the Land Rover. She stated she felt the impact and looked back through the rear window and remained in the vehicle until later.

I responded to Good Samaritan Hospital and made contact with Getsinger in Emergency Room #28. She was awake, conscious, and alert. Her pupils had regained normal size. I advised Getsinger the crash investigation was complete and I was now conducting a DUI investigation. I advised Getsinger of her Miranda Warnings and she stated she understood. I asked Getsinger if she knew what street she was on and she replied, "Turning from Tamarind to Parker at the red light, the red light at Okeechobee Rd." I asked her where she was coming from and she replied, "I was coming from Tamarind heading toward Parker." I asked Getsinger where on Tamarind she was coming from and she replied "I don't know the name of the street." I asked Getsinger where she was going and she replied, "I was going back to my house, I needed to be at work at four o'clock." I asked Getsinger how long before the collision did she use and she replied, "about an hour before." I asked Getsinger if she used the needle that was in her bra and she shook her head yes. I asked Getsinger if she took anything else other than the heroin and she replied, "Gabapentin." I asked how much she took and she replied, "200 milligrams." I asked how long ago she took it and she replied, "one o'clock." I asked why she took it and she replied, "It's prescribed to her."

I returned to Stiefel's room with a sealed Tritech Forensics blood kit. At 1654 HRS I requested Getsinger submit to a lawful test of her blood for the purpose of determining the alcohol content and/or presence of chemical and controlled substances. Getsinger asked what would happen if she stated no. I advised Getsinger if she refused to submit to the test I have requested her privilege to operate a motor vehicle would be suspended for a period of 1 year for a first refusal or 18 months if her license has previously been suspended for refusing to submit to a lawful test of her breath urine or blood. Based on the decision made in Birchfield v. North Dakota Getsinger was not told if she had a prior refusal she would be criminally charged with a 2nd refusal. Additionally she was not told the refusal would be used against her in the court of law. Getsinger consented to the blood test and signed the consent form.

At 1702 HRS, Getsinger's blood was drawn by Registered Nurse Leah Devery utilizing Tritech Forensics Blood Specimen Kit (Lot #27633 EXP: 8/31/17) which I supplied. I cleared the hospital and tot'd. the blood kit to WPBPD evidence.

On Thursday 7/6/2017 I received the blood results from Senior Forensic Scientist Nicholas Tiscione who is employed by the Palm Beach County Sheriffs Office Crime Laboratory. The results revealed at the time the blood was drawn Getsinger's blood did not detect any blood alcohol. Her blood drug analysis detected: Carfentanil and Clonazepam at 10 +/- 3 ng/mL. Based on my training and experience as a (DRE) Drug Recognition Expert, at the time Getsinger's blood was drawn she had a poly drug mix in his system consistent with Central Nervous System (CNS) Depressant and Narcotic Analgesics.

Based on the above facts and facts gathered from the initial investigation probable cause was prepared for the arrest of Getsinger for FSS 316.193(3)(C)(1) Driving While Under the Influence Causing Damage to Property.


