(Specifically include facts constituting cause for arrest.)</p> <p>I was dispatched a vehicle collision involving a white Mercury and a PBSO patrol vehicle (Asset # 68608, Tag #54271). The crash scene was located near the intersection of S. Dixie Hwy and Prospect Rd, in unincorporated Palm Beach County. I arrived on scene at approximately 22:20 hours and observed the white Mercury still touching the rear of the patrol vehicle.</p> <p>After I positioned my vehicle behind the crash scene, D/S Perez #31830 informed me that the driver had rear-ended his patrol vehicle and she had not yet exited the vehicle. I walked up and make contact with the driver who was still sitting in the driver's seat of the 2007 white Mercury bearing Florida tag Z08CUH. The driver was an older white female, with dark hair, wearing a floral dress; later identified via DAVID photo as Ms. Beverly Forman.</p> <p>I informed her as to why I was there and asked her for her driver's license. She refused to provide me with her license or give me her name/date of birth. As I spoke to Ms. Forman I could smell the strong odor of an unknown alcoholic beverage coming from her breath. Her speech was heavily slurred and her eyes were very bloodshot/watery. During my interaction with her I observed that her mannerisms were slow and lethargic. She continuously repeated herself and asked why myself and other Deputies were there. She had no recollection of being in the collision, even though her vehicle was still up against the rear of the patrol vehicle. She exhibited severe mood swings; from crying and solemn, to angry and argumentative. While trying to communicate with her and get her name, she repeatedly make remarks that she was "fucked" and "fuck me, fuck me." At one point she attempted to use her phone. In doing so, I observed that her dexterity and ability to grasp the phone appeared heavily impaired and uncoordinated. She asked where her glasses were because she said she could not see and I had to point out that they were on the collar of her dress. I also noticed that she swayed while seated and had a difficult time focusing on the phone. After locating her phone, I saw that she called someone, then hung up on them, then put the phone to her ear upside down as if the phone was ringing.</p> <p>CSA Foster #9097 had arrived on scene and begun his crash investigation during this time. When I walked away and then came back to Ms. Forman's door, she thought I was someone else. She continued to ask me why we were there and I repeated that she had collided with the rear of the patrol vehicle in front of her. She said that she saw the lights, but then asked why the Deputy was stopped there and continued to say that it was not her fault. Her ability to retain information was very limited and she was acting very stubborn and uncooperative. During the midst of her mood swings she would sob heavily and say continue to say that she was "fucked" and asked what I would do if my family were in her position. While interacting with her I also observed that her eyelids were droopy and her muscle tone appeared very relaxed. When Ms. Forman finally did get out of the vehicle, I observed that she was very unsteady on her feet. She leaned on the vehicle for balance and swayed heavily. DUI Investigator R. Soriano #9418 arrived on scene and the investigation was turned over to him.</p> <p>That concluded my involvement in the case.</p>

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Tuesday, September 18, 2019 at approximately 23:43 hours, I responded to a vehicle crash involving a PBSO department vehicle near the intersection of Prospect Road and S Dixie Highway in the City of Lantana (Palm Beach County). Upon my arrival, I observed several patrol cars with their emergency lights activated facing northbound in the right lane of S Dixie Highway. As I got closer to the scene, I observed the front of a white Lincoln Town car bearing Florida tag #Z08 CUH resting against the rear of a white Ford Interceptor sedan bearing Florida permanent law enforcement tag #54271. Upon exiting my patrol car, I met with Deputy Josh Perez I.D #31830 who told me the following, "while on scene as back on a traffic stop, I was rear ended by a white Lincoln sedan, bearing Florida tag "Z08CUH". I made contact with the driver, later identified as Beverly Anne Forman. While speaking with Forman, I observed her movements were extremely lethargic. Forman did not know she was involved in a motor vehicle crash. Forman kept stating she did not hit my vehicle." I asked Forman for her driver's license to which she began fumbling around in the vehicle with several items in passenger compartment." (Refer to Deputy Perez supplemental p.c.) I then met with Deputy Dalton who also responded to the scene in order to investigate the crash case before learning Community Service Aide Foster responded to work crash portion. Deputy Dalton met with Forman who was still seated in the vehicle and detected several indicators of impairment. (Refer to his supplemental p.c.)

OBSERVATION OF DRIVER:

I approached the vehicle on the driver side and met with Forman who was still seated in the vehicle and was crying while on her cell phone. Her eyes were red and glossy and she was very resistant in regards to hanging up her phone and exiting the vehicle. I observed Forman was a long pink dress and was seated in the driver seat of the white Lincoln Town car. While speaking with Forman, in attempts to ask question and investigate for driving under the influence. Forman ignored me and continued talking on her cell phone. I asked Forman to hand up the phone which she eventually did and was asked to exit the vehicle which she ultimately did. As I attempted to introduce myself and explain to Forman why I had been summoned to the scene, she once again became resistant and did not want to exit her vehicle. Finally Forman exited her vehicle after several minutes and was asked to submit to standardized field sobriety tasks (SFST's) which she stated she was not going to do. Forman was read Taylor warnings which she refused to understand and ultimately stated she was not going to participate in SFSTs and was placed into PBSO issued handcuffs which were double locked and checked for proper fit.

DRIVER'S STATEMENTS:

Forman stated she drank wine and repeatedly stated she was not involved in a crash. Forman stated multiple times she did not want to be arrested and would state do you know who I am? Forman stated she had medical issues and would not explain what and or if she took medication.

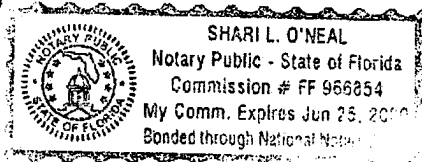

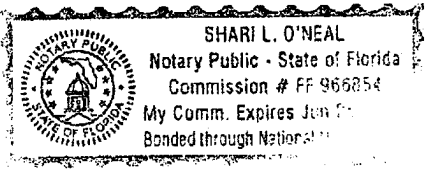
