On the 21 day of May, 2018 at 03:12 (Specifically include facts constituting cause for arrest)

On Monday, May 21, 2018, at approximately 0245 hours, I was in the area of Lilac Street and Golfers Drive West in the City Limits of Palm Beach Gardens. I was on patrol in full Palm Beach Gardens Police Department uniform with a badge upon my left chest, and a patch upon each shoulder, I was also in a marked Police vehicle equipped with emergency equipment. I drove by a parked red vehicle which had the lights on facing in a northwest direction on the corner of the roadway. I continued to patrol the area and I returned to the area of Lilac Street and Golfers Drive West. I was equipped with my Body Worn Camera for this incident.

Once in the area I observed a white male on the southside of Lilac Street near the 4300 block. The male was near the parking lot of 4350 Lilac Street. I observed the male walking towards the red vehicle. At this point in time I attempted to make contact with the male and the vehicle. I notified dispatch of the vehicle which was a red Ford Focus (FL Tag #ENBN58). I attempted to stop the male due to him walking from the area of numerous parked vehicles. He was walking towards a running vehicle which was not parked in the parking lot area he was coming from. This area has had many vehicle burglaries recently. Due to this I believed a crime was possibly being committed and was attempting to conduct a Terry Stop. The vehicle was also parked in the roadway not moving, committing a traffic violation.

Upon exiting my patrol vehicle, I attempted to make contact with the male, who was later identified as Ronaldo Antonio Perez Perez. He was walking towards the passenger side of the vehicle. I told him to stop. Ronaldo continued to walk away from me and towards the vehicle. I again told him to stop. Ronaldo looked at me and continued to walk towards the vehicle. As he walked towards the vehicle he was laughing. Ronaldo then entered the vehicle on the passenger side.

As I approached the vehicle I was standing at the driver's side window. I observed the



driver to be a female, and the male to be seated in the passenger seat of the vehicle. I shinned my light into the driver's side of the vehicle. I asked the driver, later identified as Bilma Elibet Garcia Perez, to roll down the window. Bilma did not comply. I again told the driver to roll down the window, and she did not acknowledge me and looked at the passenger. I knocked on the window and told her to roll down the window. Bilma then looked at me with a smile on her face and put the car into drive. She then took off with me standing right next to the driver side window. I got away from the vehicle as fast as I could to avoid being hit, because I believed I was going to be struck by the vehicle as it attempted to flee. Due to the positioning of the vehicle and myself I felt that had I not moved the rear of the vehicle and rear tires would have struck me. I ran to my vehicle and drove after the suspect vehicle. I immediately notified dispatch that the vehicle had fled and almost struck me while doing so.

The vehicle came to a stop approximately 200 feet north of Lilac Street on Golfers Drive West. I immediately began to conduct a high-risk traffic stop on the suspect vehicle, it should be noted my emergency equipment was activated. As I ordered all occupants to place their hands out the window, they refused. I continued to give loud verbal commands and they did not comply. As more law enforcement officers arrived on scene we attempted to get the occupants of the vehicle to comply. They continued to not comply. I asked the driver to exit the vehicle and she did not. The passenger (Ronaldo) then exited the vehicle, even after being told to not exit the vehicle. At this point in time based on the fact that both suspects refused to cooperate numerous Officers approached the vehicle. We were able to take Bilma and Ronaldo into custody.

I placed Bilma into my patrol vehicle. I later read her Miranda off my department issued card. After Bilma was informed of her rights she stated she did not wish to speak to me. It should be noted while speaking to Bilma I smelled the strong odor of alcohol emanating from her breath and person as she spoke. At this point in time I find probable cause to place Bilma Elibet Garcia Perez under arrest for violation of Florida State Statute 784.07(2)(C) Aggravated Assault on a Law Enforcement Officer for attempting to drive away with me at the side of her vehicle. I was in fear that if I did not get out of the way of the vehicle I would have been struck by the car. I was so in fear of getting struck I got out of the way and began running back to my patrol vehicle. I also find probable cause for violation of Florida State Statute 843.02 Resisting Arrest Without Violence for refusing to open the door to the vehicle, for attempting to leave in the vehicle, and for refusing to follow lawful commands while being ordered to place her hands out the window of the vehicle and to exit. She did not comply with any lawful order.

I was informed by other officers on scene that Ronaldo had in his possession numerous identifications which appeared to be false. There was a Florida ID Card which had the name Robert Murda on it. The number on the ID Card did not exist. A social security card with the name Robert Murda on it and the social security number [REDACTED] on it was

P R O B A B L E C A U S E	<p>present as well. This social security card was found to be fake as well. There was an ADP Visa card in the name Robert Murda in his possession. A Mexico national ID card was found in the name Melvin Leonel Barrios Perez, which was real but did not belong to Ronaldo. A Guatemala national ID Card in the name Ronaldo Antonio Perez Perez was found in his possession. Ronaldo did not speak English so Jupiter Police Officer Quiros (#305) arrived on scene to assist with translation. When Ronaldo was asked his name, he stated Melvin Perez Barrios. It should be noted that this is also not his correct name. He was then transported to the Palm Beach Gardens Police Department for further interview.</p> <p>Officer Quiros read Ronaldo Miranda Rights in Spanish. His Body Worn Camera was activated. I was informed by Officer Quiros after the interview that Ronaldo stated he lived at 4253 Lilac Street. He was walking to meet his cousin (Bilma). He stated he saw me and knew I was a Police Officer but wanted to get into the car. Ronaldo told his cousin I was a Police Officer and he didn't know why she took off. He stated he was going to meet her because she was drunk, and he was going to drive her home. He stated that the Florida ID Card in the name Robert Murda he purchased for \$500.00 and the social security card was fake as well. He said he used that information to gain employment at Brio (Palm Beach Gardens). He used fake documents because he is not a citizen. He informed Officer Quiros that the Visa card in the name Robert Murda was given to him from his work. He stated he knew it was all fake documents. The Mexico national ID card was said to be his cousin. He stated he uses the ID because it stated he is 24 years old and he is in fact only 20 years old. This is used as a fake ID. Ronaldo then stated that his real name is Ronaldo Antonio Perez Perez.</p>					
S T A T E M E N T	<p>I find probable cause to place Ronaldo Antonio Perez Perez under arrest for violation of Florida State statute 901.36(1) Fraud-Give False Identification to Law Enforcement Officer for providing to Officer Quiros the name Melvin Perez Barrios knowing that was not his correct name. At the time he was lawfully detained and knowingly falsely identified himself. I find probable cause for violation of Florida State Statute 843.02 Resisting Arrest without Violence for knowing I was a Police Officer attempting to legally detain him and walking away and entering a vehicle which attempted to flee. He then refused to comply with lawful commands. I find probable cause for violation of Florida State Statute 322.212(1)(C) ID- Possession Similitude of Identification for possessing a fake Florida ID Card, a fake Social Security Card, and a fake Mexico national ID Card.</p> <p>Ronaldo and Bilma were transported to the Palm Beach County Jail without incident.</p> <p>The vehicle was towed by Kauff's Towing off rotation from the scene. A tow sheet was completed and later submitted. I later submitted the Social Security Card, Florida ID Card, Visa Card, and Mexico national ID Card into evidence for this case. See all Body Camera Footage for further on every officer's involvement and actions at the time of the incident.</p>
