(Specifically include facts constituting cause for arrest.)</p> <p>the defendant, Blair Sloyer, did commit the act of simple battery while at 4375 Belvedere Road, Walmart, located in unincorporated West Palm Beach, Palm Beach County, Florida.</p> <p>On the above date and time I responded to 4375 Belvedere Road, Walmart, in reference to a battery. I met with the victim/complainant, Jeffrey Hillman, who advised the following; while in the above listed business he went to the pharmacy area to utilize the blood pressure machine. While using the machine a unknown white male, later identified as the defendant, began yelling at him telling him he needed to leave Walmart. He advised he did not know what the defendant was talking about and then all of a sudden the defendant picked up a collapsible walking cane with the three prong suction cup bottom which was still in the box and pushed it in his face causing a minor scratch to the left side of his nose as well as a red mark to the right arm because he raised his arm to move the cane out of his face. He stated the defendant then became belligerent and continued acting irrationally. He stated at this time he called several Walmart employees to call the police. He stated while waiting on the police the defendant was acting totally out of control. He stated the defendant then began talking to himself and knocking things off the shelf of the business.</p> <p>Upon arrival I observed the defendant pick up a toy costume pitch fork and then put it down once he realized I was a police officer/deputy sheriff.</p> <p>I met with the defendant who immediately told me he was scared of the victim, Hillman, because he believed he was stalking him. He stated he was inside of Walmart using the blood pressure machine and as soon as he got up and began talking to a customer this Hillman guy came up behind him. The defendant admitted he pushed the collapsible cane into Hillman's face in an effort to shove him away from him to get him to leave him alone. The defendant stated he does have mental issues but Hillman was stalking him. Based on the defendant's admission as well as Hillman's sworn statement as well as video surveillance I had probable cause to arrest and charge the defendant with simple battery based on the minor scratch injury the victim received per FSS 784.03(1a1).</p>
