<p>On 07/29/2017 at 2303 hours, I observed a black Nissan Altima bearing FL Tag EWPK47 stopped in the roadway facing eastbound near 300 W Palmetto Park Road, Boca Raton, FL. There were vehicles in the area and traffic was moving. The front passenger head light was not working on the vehicle. The vehicle began to move and drive eastbound on Palmetto Park Road. I stopped the vehicle at 10 E Palmetto Park Road, Boca Raton, FL and made contact with the driver W/M Blake Permut. I noticed the vehicle had damage located on the front and passenger side of the vehicle and I checked with the Boca Raton Communications Center to see if there were any reported hit &amp; run crashes with negative results.</p>												
<p>I explained to Blake that I stopped him for stopping in traffic and for having no front passenger headlight. I requested Blake's drivers license, registration and insurance. Blake gave me his Florida drivers license and he did not provide me with the registration and insurance. Blake told me he was "done" and he was "parked." I could smell a strong alcoholic beverage smell emanating from Blake's breath. Blake's speech was slurred and his eyes were glassy/ bloodshot. Blake told me he was coming from a concert and he had two beers. He later told me he should not be driving and he agrees that he is not sober. At this point I asked Paul to conduct some roadside exercises and he said yes. Blake told me he has no medical issues and he does not take prescription or illegal drugs.</p>												
<p>First, Blake conducted the Horizontal Gaze Nystagmus Exercise and he advised he understood my instructions. He displayed a lack of smooth pursuit in the right and left eye. He also displayed a distinct nystagmus at maximum deviation and an onset of nystagmus prior to forty five degrees in the right and left eyes.</p>												
<p>Next, I asked Blake to conduct the Walk and Turn exercise. Blake advised he understood my instructions. Blake was double stepping and he did not use heel to toe steps</p>

<p>throughout the exercise. Blake was uneasy on his feet and he was having difficulties balancing on the line. Blake made an improper turn and I had to remind him to continue with the last nine steps.</p> <p>Lastly, I asked Blake to conduct the one leg stand exercise and he advised he understood my instructions. Blake did not count out loud and he dropped his foot numerous times during this exercise. Blake had to use his arms to balance and he was swaying throughout this exercise.</p> <p>Based on my training (DRE #028046), experience and the totality of circumstances, Blake was placed under arrest for driving under the influence. I transported him to the Boca Raton Police Department and Officer Miller conducted the breath tech operation. Blake refused twice to provide a lawful breath sample and I read him implied consent. Blake was transported to Palm Beach County Jail and his vehicle was towed to Westway Towing on 07/30/2017. The video of the incident was downloaded into evidence on 07/30/2017.</p> <p>Per Florida State Statute 316.193(1), Blake did drive or was in actual physical control of a vehicle, while under the influence of alcoholic beverages/ chemical substances and was affected to the extent that his normal faculties were impaired.</p>
