DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I responded to the 800 block of N. Ocean Blvd in reference to a crash. The driver of vehicle of said that she was traveling northbound on N. Ocean Blvd at the intersection of George Bush Blvd and vehicle (V1) was traveling eastbound on George Blvd approaching the intersection of N. Ocean Blvd. D2 said that driver 1 run a red light, which caused the crash. The left front of V2 struck the left side of V1. I observed extensive damage to both vehicles and debris on the roadway. During the course of the investigation, the witness confirmed D2's statement.

OBSERVATION OF DRIVER:

As I was talking to Martin, I could smell a strong odor of an unknown alcoholic substance emanating from her breath. Martin appeared to be impaired, red, glassy eyes and slow dexterity. There was a strong odor of an unknown alcoholic beverage coming from her person. Martin had difficulty standing on her own two feet. Once Martin was released from the hospital, I transported her to the Palm Beach County BAT facility where she refused to submit to a breath test to determine her breath alcohol content. While at the hospital, Baker stated that she had some drinks prior to the crash but refused to answer any other questions.

DRIVER'S STATEMENTS:

I advised Martin that I'm conducting a criminal investigation and she advised me that she was involved in the crash. Martin said that she made a left turn onto N. Ocean Blvd and D2 struck her car, but refused to answer any other questions. BDFD responded, treated, and released both drivers at the scene. I transported Martin to Delray Medical to be medically cleared. While at the hospital, Martin said that she had a few drinks at the new IPic in Delray Beach prior to the crash but refused to answer any other questions.

ODORS:

I could smell a strong odor of an unknown alcoholic substance emanating from her breath.
