## NARRATIVE:

On Saturday, July 21, 2018 at 1624 hours I responded to a possible intoxicated individual causing a disturbance at the Blue Bar, Concourse C of the Palm Beach International Airport, 3200 Belvedere Road in West Palm Beach, FL 33406. Upon arrival I made contact with a white male subject later identified as Brad Fisher. Fisher was yelling at airline employees and customers were observed leaving the area due to his disruptive behavior. Fisher was found to be in the company of his three children, Andrew, Hanna, and Emily Fisher, all under the age of eleven. Fisher's language was severely slurred and I learned he had been drinking at the bar for some time while the children were crying. I learned through airline employees that the Fishers were supposed to be departing on Jet Blue Flight 1944 to Newark at 1710 but, due to his behavior and apparent intoxication, Brad Fisher was not to be allowed to fly. Repeated attempts were made to calm Brad Fisher once the children were separated from him but he refused and continued yelling incoherently. The children was visibly scared and crying and had to be consoled. Brad Fisher was also warned repeatedly that his refusal to obey by legal commands would lead to his arrest. Fisher then stood up against our orders and attempted to walk away stumbling and had to be restrained for his safety. Palm Beach Fire Rescue responded and examined Brad Fisher and also concluded he appeared to be under the influence of unknown substances or alcohol. Again and again, Brad Fisher attempted to flee from myself and assisting deputies and had to be physically restrained for his safety as well as ours. As a result, Brad Fisher was arrested and charged with disorderly intoxication. Sarah Fisher, who is the mother of the children, was contacted and advised of the incident. She spoke with Jet Blue officials and arrangements were made to fly the children on the next flight with Jet Blue with her consent. Brad Fisher was later transported to Palm Beach County Jail without further incident.
