


On July 24, 2017 at approximately 2205 hours I was was in the center median of State Road 7 approximately 500 north of the intersection with Boynton Beach Blvd, unincorporated Boynton Beach, Palm Beach County, monitoring traffic in the area. I saw defendant's vehicle, a Black GMC Denali bearing FL tag GFTD10, travelling north bound in the center lane. The vehicle passed on vehicle and then was the sole vehicle in the roadway. I estimated the vehicles speed to be in excess of 80 mph in a 50 mph zone. I activated my STALKER DUAL SL SERIAL # DC107982 FRONT ANTENNA SERIAL # KC064472 with gave a digital read out of 83 mph with matching audio Doppler tone.

As the vehicle passed my position the vehicle slowed down to approximately 55 mph and changed lanes to the #3 lane closet to the grass. I got behind the vehicle and saw that the vehicle was swerving from side to side. I activated my emergency over head lights in order to affect a traffic stop of the vehicle. The vehicle continued travelling for approximately 1/10th of a mile prior to stopping. Once the vehicle pulled into the right turn lane. The vehicle kept rolling approximately 30-40 feet prior to coming to a complete stop.

I approached the vehicle on the passenger side. The defendant, Brad E. Heard, was the sole occupant of the vehicle in the driver seat. I could smell the immediate strong odor of an unknown alcoholic beverage, know to me based on my training and experience, coming from the vehicle. While speaking with the defendant I could see that his eyes were red, blood shot and glassy and his speech was slurred.

I asked the defendant for his driver's license, registration, and insurance. He pulled out his wallet without looking for his license and then went into the center console to attempt to locate the registration. After a few minutes of looking for his registration I asked the defendant again for his driver's license. He opened his wallet and pulled out a red unknown credit or debit card but did not hand it to me. He did not put it back in the wallet. While speaking with the defendant he would stop looking for the items requested of him. He had to be reminded multiple times to continue looking for his Driver's License, and registration. The defendant then gave up looking for his paperwork.

I asked the defendant for his name and date of birth which he gave to me. I then asked him for his social security number to verify his identity through the Driver and Vehicle Information Database (D.A.V.I.D). He gave me the first 5 digits without issue and then hesitated prior to giving me the last 4 digits.

When I advised the defendant of the reason for the stop, speeding, he stated that I must have been confused because he was flowing with the surrounding traffic. During the course of the stop I asked the defendant where he was coming from and he advised me that he was coming from Seminole coconut creek casino. He stated that he had a few drinks while he was there. He stated that he was heading home in the Palm Beach Garden's area. I asked him what road he was on and he stated that he was on the turnpike. I asked him where on the turnpike and he stated that he was using the navigations for that reason. From my position at the time the navigation did not appear to be activated. I asked the defendant if he had any medical conditions including diabetes and he stated that he did not. He stated that he did not go to the doctor or dentist and that he had not taken any drugs to day.

Due to the signs of impairment I had dispatch contact the Driving Under the Influence (DUI) unit to see if an Investigator was available. Inv. C. Ficarra # 8368 responded to the scene and took over the investigation.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/24/2017 at approximately 2234 hours I responded to the 9000 block of State Road 7 (northbound), in unincorporated Palm Beach County, in reference to a DUI investigation. Upon my arrival I observed a black GMC Yukon SUV bearing Florida tag GFTD10 stopped on the eastside of State Road 7 facing northbound at the intersection of an unfinished roadway. I then met with the original stopping deputy, Deputy Ward ID:16305, who stated to me the following: He stated that he observed the Yukon traveling approximately 85 mph in a 50 mph zone. When the vehicle passed him it slowed down and moved from the center travel lane to the lane closest to the grass shoulder. Deputy Ward observed the vehicle swerve in its own travel lane while traveling approximately 50 mph. As Deputy Ward conducted a traffic stop of the vehicle it did not immediately pull over but continued further, stopping in the center of the intersection of the unfinished roadway where Deputy Ward had come to a final stop before moving forward to its final rest position. When he approached the vehicle he immediately could smell the odor of an alcoholic beverage, saw the driver's eyes were bloodshot and watery, and observed his speech was slurred. Deputy Ward asked the driver where he was going who stated that he must be confused with other traffic. Deputy Ward stated that the GMC passed one other vehicle and then there was no further traffic.

OBSERVATION OF DRIVER:

The driver stated that he was on the turnpike heading home to Palm Beach Gardens. The driver stated that he was coming from a casino down south. The driver advised that he did have a couple of drinks but as Deputy Ward started to clarify what kind of drinks he stated "standard drinks." The driver had been looking for his driver's license, vehicle registration, and vehicle insurance since Deputy Ward had stopped him approximately 25 minutes prior but had yet to produce them. The driver would stop looking for the documents as Deputy Ward spoke with him then continue to look once finished talking until he stopped looking all together. The driver identified himself verbally as Brad E. Heard (confirmed through DAVID) who did have a valid Florida driver's license. I then approached the GMC and made contact with Brad through the open driver's side front window.

DRIVER'S STATEMENTS:

I observed that he was sitting in the driver's seat and was alone in the vehicle. I immediately observed that his eyes were red, glassy, bloodshot, and droopy. He had a dazed appearance and seemed lethargic. I identified myself to him and asked him if he knew why he got stopped to which he stated he was not told. I explained to him the reason was for the speeding and swerving which he did not remember. I asked Brad if he was able to locate any of the requested documents which he stated he had been trying. ODORS:

The obvious odor of an unknown alcoholic beverage on his breath as he spoke

GENERAL OBSERVATIONS

SPEECH: Slurred, mumbled, unclear, slowed

ATTITUDE: Mood swing, argumentative, difficult, dazed looking, forgetful

CLOTHING: Gray t-shirt, gray long pants, gray shoes

MEDICAL/OTHER: No medical issues (no diabetes or seizures), no physical defects or injuries, no issues with eyes (no glasses or contacts), no prescription medication illegal drugs or marijuana taken, stated had standard drinks, kept shoes on for tasks

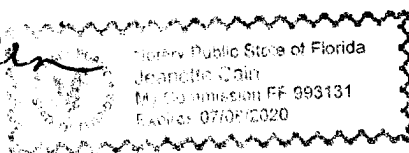




ADMINISTRATIVE	<p>I asked Brad if his license was in his wallet, which was in plain view on top of the dashboard directly in front of Brad by the steering wheel. Brad began to look for his wallet by reaching toward his back pant pocket. I alerted Brad to his wallet being in front of him at which time he stopped looking in his pocket and picked up his wallet. I observed that Brad's movements were very slow. I also observed the obvious odor of an unknown alcoholic beverage on his breath as he spoke. His speech appeared very slurred, slowed, mumbled, and unclear. As Brad looked through his wallet he fumbled with his cards never locating the license. He stated that he had looked through his wallet before and stated that his license might have been left at the casino. Brad attempted to hand me his wallet stating that I wanted to look through it which I informed him I did not. Brad stated that he didn't find his wallet or his license still attempting to hand it to me. Seeing as Brad had difficulty locating his license and was unable to provide it I asked him to step from the vehicle so I could speak with him. As Brad stepped from the vehicle I observed that he had a slight circular sway as he stood still. I asked Brad if he needed Fire Rescue for anything at which time he asked me why he would need them. I asked him if he needed medical attention for anything which Brad stated no. I asked Brad if he had any medical issues such as diabetes or seizures to which he stated no. Brad did not take any prescription medication, illegal drugs, or smoke any marijuana that night. Brad stated he had no issues with his eyes normally and did not wear glasses or contacts. Brad stated that he did not have any physical defects or injuries and stated that he could walk around without any issues. Brad stated that he did not have any speech impediments or did he talk with a slur normally. I then explained my concerns to Brad. During my explanation Brad became argumentative and questioned why I was talking to him. Brad also stumbled backward and leaned against his vehicle which stopped him from falling. I finished explaining my concerns to Brad and asked him to submit to standardized field sobriety tasks. Brad paused and did not immediately answer. Brad diverted the question and stated that I was distracted due to me observing a vehicle traveling close nearby. I explained to him that we would conduct the tasks away from the traffic if he so choose to do them. Brad stated he would do them if they were not near the road. Brad continued to question everything I was explaining to him still diverting his answer on the roadsides. Brad stated that he observed 5 to 6 cars with lights when there was clearly only 4 (all of which turned their overhead front police lights off). Seeing that Brad would not give a definitive answer I explained to him Taylor warnings (multiple times). Brad continued to divert asking what the tasks were. I explained that they were mental and physical in nature, I would explain to him the task, demonstrate the task, and he would have to remember what was explained and demonstrated and then carry the task out. Brad continually diverted the answer to do the tasks or not. He eventually stated that he would give them a try. I escorted Brad to an area away from the roadway for the tasks. Brad assisted in placing a tape line on the road way for the tasks. Brad decided to keep his shoes on for the tasks (see roadside task page for further).</p> <p>It should be noted that during an inventory of the GMC a Corona Familiar bottle cap was located on the front passenger seat. Behind the driver's seat spilled on the floorboard was an open 32 oz bottle of Corona Familiar.</p>

Other Observations:

Brad had difficulty placing his head straight as instructed. Brad's eyes tracked equally, the pupils were the same size and were appropriate for the lighting conditions, and no resting nystagmus was observed. Vertical gaze nystagmus was administered and was observed. Brad swayed in a circular motion during the task. Brad moved his arms and feet from the instructed position, didn't keep focus on the stimulus, and argued that he was distracted by other vehicles (Brad's SUV had blocked his view of most passing traffic as well). Brad became very uncooperative and difficult.

WALK & TURN:

I explained and demonstrated the instructions for the walk and turn task to Brad who stated that he understood. During the task I observed that Brad had the following cues: had difficulty getting into instructed position (raised arms, leaned to one side, swayed back and forward); stops walking to steady self/regain balance; missed heel-to-toe on all steps appearing to walk at a normal gait; stepped off the line on steps: 2 on first set then on step 1 and 9 of return set; used arms for balance (raises arms over six inches); improper turn (lifted front foot up and pivoted on heel, almost losing balance); did not count as instructed on return set.

ONE LEG STAND:

Brad became argumentative and resistant again as I asked him to face my marked PBSO patrol vehicle. Brad stated that he did not want to be "ass raped." He eventually did face the patrol vehicle even though he remained difficult. During the explanation Brad continued to interrupt me and move from the instructed position (raised arms and moved feet). Brad began to raise his leg off the ground as he argued with him prior to being told to start. I explained and demonstrated the instructions for the one leg stand task to Brad who stated that he understood. During the first attempt at the task I observed that Brad had the following cues: did not look at raised foot, swayed side to side, and did not count as instructed. I asked him to put his foot down at which time I reexplained the instructions which he stated he understood. Brad then showed the following cues: swayed while balancing; used arms for balance (raises arms over six inches); hopped while balancing; put foot down twice (before 30 seconds) at which time he stopped doing the task.

FINGER TO NOSE:

Brad had difficulty placing his feet in the instructed position but he eventually did. I explained and demonstrated the instructions for the finger to nose task to Brad. I explained what is considered the tip of the finger and tip of the nose to Brad who stated that he understood. Brad also knew his left from his right. Brad moved his arms touching his fingers together before being instructed to. During the task I observed that Brad had the following cues: did not keep eyes closed (peeked); mashed his nose with the pad of his finger on each instructed hand; began to raise left hand when called for right on 5th instructed hand; swayed in a circular motion during task; touched top of nose on 1 and 3 instructed hand.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the Romberg with recitation task to Brad who stated that he understood. I asked him to say but not sing his ABCs without stopping which he stated he could. During the task I observed that Brad had the following cues: swayed in a circular motion during the task; moved from instructed position (hands raised); tilted head back before being instructed to do so; stated up to S then mumbled T U V D stated "sorry" then continued at "V W X Y and Z"

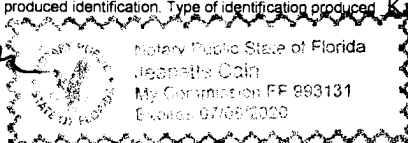
