ON 10/22/18 AT APPROX. 1810 HOURS I RESPONDED TO 19937 TREVI WAY BOCA RATON IN REFERENCE TO A BURGLARY TO A RESIDENCE.

UPON ARRIVAL, I MADE CONTACT WITH ELAINE POTAK AND SHE ADVISED THAT HER HOME WAS BURGLARIZED BY HER GRAND DAUGHTER [REDACTED] AND HER BOYFRIEND BRADEN BRUFFORD.

ELAINE ADVISED THAT HER SON STEVEN INSTALLED SURVEILLANCE CAMERAS AROUND THE INSIDE OF HER HOME AND STEVEN SHOWED ME THE SURVEILLANCE RECORDING ON HIS PHONE AT THE TIME OF THE BURIGARY.

ON THE RECORDING, I CAN CLEARLY SEE [REDACTED] CAME IN TO THE LIVING ROOM FROM THE BATHROOM WHERE ONE OF THE WINDOW WAS UNLOCKED. [REDACTED] THAN WENT OVER TO ONE OF THE SLIDING GLASS DOOR AND OPENED IT TO LET HER BOYFRIEND BRADEN IN TO THE RESIDENCE. ONCE INSIDE, [REDACTED] AND BRADEN WENT IN TO ELAINE'S BEDROOM AND REMOVED \$350 CASH, A WHITE GOLD DIAMOND RING, A GOLD EARRING, AND A YELLOW GOLD DIAMOND RING. TOTAL APPROX. VALUE STOLEN \$5100.

[REDACTED] AND BRADEN THAN LEFT THE RESIDENCE THOUGH THE SLIDING GLASS DOOR. STEVEN AND ELAINE POSITIVELY IDENTIFIED [REDACTED] AND BRADEN FROM THE VIDEO THAT THEY WERE THE ONE THAT BREAK IN TO THEIR HOME.

BOTH STEVEN AND ELAINE ADVISED THAT [REDACTED] AND BRADEN DOES NOT LIVE AT THE ABOVE ADDRESS AND STATED THAT BOTH [REDACTED] AND BRADEN WERE NOT ALLOW IN TO THEIR RSIDENCE.

BRADEN THOMAS BRUFFORD DID KNOWINGLY ENTER OR REMAIN IN A DWELLING, THE PROPERTY OF ELAINE POTAK WITH THE INTENT TO COMMIT AN OFFENSE THEREIN, CONTRARY TO F.S.S 810.02(1)and(3).
