

# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 3/6/18 at approximately 0022 hours, Jupiter Police Dispatch received an anonymous phone call stating a black Jeep Commander with Florida License Plate IDRY13 was seen about 10 minutes prior driving recklessly and running over a curb as it entered Abacoa Plaza, located in the 5400 block of Military Trail. Officer Schneider responded to the area and located the vehicle, unoccupied, in the parking lot of the McDonald's Restaurant located at 5480 Military Trail. I responded to the area a few minutes later. Officer Schnieder and I observed traffic around the McDonald's from the nearby plaza. No one went to the vehicle. At approximately 0115 hours, I left the area. A moment later Officer Schneider advised me that the vehicle was now occupied. I returned to the plaza and found that the vehicle had moved to the front of the Publix store and was parked across more than one marked parking space. Officer Schneider advised me that he had seen the driver operating the vehicle. Officer Schneider and I parked our vehicles in the row behind the SUV. As we approached the driver's side window, the driver and sole occupant, Bradley Underwood, opened the window. I introduced myself.

### OBSERVATION OF DRIVER:

Underwood was tapping repeatedly on the screen of a phone which did not appear to be turned on. Underwood's eyes were glassy. Underwood had slurred speech and at that time I could smell the odor of an unknown alcoholic beverage on Underwood's breath.

### DRIVER'S STATEMENTS:

I asked Underwood if he'd been drinking. Underwood indicated he had been drinking earlier. After I had Underwood exit the vehicle, he was hesitant to complete roadsides, indicating that he had not been driving and that he wasn't driving due to drinking earlier. I advised Underwood of his Taylor Warnings. Underwood prevaricated for several minutes. Underwood eventually agreed to complete roadside tasks.


