

<p>On Sunday, September 15, 2019 at approximately 1538 hours I arrived at 2400 N Flagler Dr in reference to a stabbing. Upon arrival I made contact with Thomas Davis Jr. (W/N DOB: 07/16/1942) who was sitting in a red BMW bearing Oklahoma tag ELA276 bleeding from the back of the head.</p> <p>Davis advised the following under a sworn statement. Davis advised he was sitting on the shoulder of the road in the 2400 block of N Flagler with his friend Anna Marshall (W/F DOB: 06/15/1975) when a red Ford pickup truck was southbound on Flagler and entered the opposite lane of traffic and stopped next to his vehicle. A white male exited the vehicle and Davis asked "who are you" Davis then realized who the male was and advised his name was Bradley Harpster (W/M DOB: 06/26/1995) . Davis stated he realized who Harpster was because he was doing work with Harpsters father at his residence at 524 35Th St and has seen Harpster in passing. Davis advised Harpster to leave him alone and that he wasn't going to hire his father for anymore work because he was a drunk and a crack head. Harpster was reportedly angry and retrieved a "bowing knife" from his center console of his vehicle. Davis advised he started rolling up his windows and tried to drive off when Harpster started stabbing the Black convertible canvas top of the BMW. (IT should be noted that Davis front seat was leaned slightly back and every laceration to the canvas top was directly over where Davis Head was located.) Davis stated that because he rolled up the window Harpster was trying to stab him through the canvas.</p> <p>Davis had a minor laceration approximately .5 inches in length with mild blood in his hair. Davis stated that he would seek medical attention after completing the investigation.</p> <p>It should also be known that Davis could provide Officers Harpsters name, address, and where we could locate him.</p> <p>I also spoke to Marshall who advised that her and Davis were sitting in the car because</p>




	<p>they just got done working on a sailboat and the "plum" truck came into their lane a white male with tattoos all over his arm started cussing at Davis. (It should be noted that the right arm of Davis is completely covered in tattoos.) Marshall advised that Davis and Harpster continued to exchange "fuck you" at each other before Harpster entered his truck and grabbed out a long knife according to Marshall. Marshall advised the handle and blade were both plum color and Harpster used the knife to attack Davis. Marshall advised she was in fear for Davis because Harpster appeared very angry and continued to stab the canvas after already striking Davis in the head.</p> <p>I provided the information Davis gave me to officers who were circulating the area. Officers located a red Ford pickup truck in front of 524 35th ST. Officers were able to locate Harpster in front of the residence and a show up was completed.</p> <p>I advised Davis that the person he will see may or may not be the person that attacked him. If he is positive, unsure, or can positively state that the person he may see is the not suspect to let me know. Davis advised he understood. I drove Davis to the 500 block of 35th ST and he stated that he was positive that Harpster is the male who attacked him.</p> <p>Harpster was arrested (handcuffs were double locked and checked for proper spacing.) and transported to booking.</p> <p>Officer Walters advised that in plain view inside the center console of the red Ford was camper style bowing knife. (Vehicle was towed to West Palm Beach Police Department vehicle evidence area while warrant is being prepared)</p> <p>I read Harpster his Miranda Rights via the West Palm Beach Issued Miranda Card. I asked Harpster to explain to me what happen today. Harper advised that he arrived home from work and several police officers approached him and he did not know what was going on.</p> <p>I then asked Harpster if he made any stops before going home and he replied that he drove straight home from Lake Worth to his residence. I asked him the direction he traveled and he stated that he takes Flagler North. I asked how far on Flagler he travels before turning and he states that he usually turns somewhere near Currie Park.</p> <p>As reported in the beginning of the Probable Cause Currie Park is located on 2400 N Flagler and Harpster admits to traveling in the area.</p> <p>I asked Harpster if he was sure he did not make any stops before going home and he continued to state that he went straight home. Harpster was then asked about the Knife. Harpster replied which knife I have tons of knives. I then stated the knife inside your vehicle. Harpster advised that the knife is his. I asked Harpster to describe the knife to me because I had not seen it and he stated it's "all black".</p>



